FOREWORD

In pursuance of Sub-rule 2 of Rule 25 of the Rules of Business 1973, each Division is required to prepare a Year Book covering its activities, progress and achievements during the preceding financial year 2020-21, for information of the Cabinet Division and general public. The Year Book is uploaded on Ministry's website.

During 2021, the government implemented stimulus packages of Rs. 1.4 trillion and COVID-19 responsive federal PSDP at Rs. 650 billion including foreign aid of Rs. 73 billion (217 projects were completed). As a result, GDP registered a V-shaped recovery of 3.94 percent at the back of agriculture (2.77 percent), industries (3.57 percent) and services (4.43 percent). Per capita income increased from \$ 1,361 to \$1,543.

This Year Book provides an opportunity to the readers to appreciate the economic policy input and streamlined implementation of PSDP by the team at M/o PD&SI under the leadership of Honourable Minister, Mr. Asad Umar to ensure the benefits of inclusive growth to the people of Pakistan. Contribution of Plan Coordination Section under the supervision of Dr. Muhammad Ahmed, Chief Economist is acknowledged and appreciated. Comments and suggestions to improve quality of Year Book are encouraged.



INTRODUCTION

The Ministry of Planning, Development & Special Initiatives is designated as Secretariat of Planning Commission; to provide administrative and logistic support enabling the assignments in efficient and effective manner. The Planning Commission works as a think tank for policy formulation input in respect to the socio-economic development in the country. It formulates/carries out economic policies, evaluates economic situation, prepare National Development Plans and evaluate implementation in collaboration with the respective ministries, divisions and provincial governments.

The Prime Minister is the Chairman of the Planning Commission; assisted by the Deputy Chairman and the Minister for PD&SI. The Governing Council comprises twelve members including Secretary Planning Division who works as Member Coordination.

The Planning Commission is responsible to perform functions as indicated in the Schedule-II of the Rules of Business 1973 which inter-alia includes:

- Preparing the National Plan and review and evaluating its implementation.
- Formulating Annual Plan and Annual Development Plan.
- Monitoring and evaluating implementation of major development projects and programmes.
- Stimulating preparation of sound projects in regions and sectors lacking adequate portfolio.
- Continuously evaluating the economic situation and coordinate economic policies.
- Organising research and analytical studies for economic decision making.

The Planning Commission also discharges the following functions:

- Assisting in defining the national vision and under taking strategic planning.
- Assessing the material, capital and human resources of the country and formulating proposals for augmenting such resources.
- Assisting the government in providing a conducive macroeconomic and regulatory framework, improved resource mobilisation, an institutional framework and efficient public investment.
- Promoting and developing role of the private sector as an engine of growth by co-opting it as a partner in the development process through institutionalised effective consultative process.
- Promoting and coordinating Special Initiatives and innovation in the government in partnership with the relevant ministries, divisions and organisations.
- Promoting and developing social capital for development with the stakeholders (SDGs, poverty alleviation, social harmony).
- Promoting, coordinating economic and infrastructure initiatives towards developing regional economic integration.
- Monitoring Pakistan's economic competitiveness and development strategies for its enhancement with the relevant ministries, divisions and organisations.
- Promoting development discourse towards participatory and collaborative planning and development.
- Study trends and evaluate impact of globalisation and develop appropriate national responses in coordination with the relevant ministries, divisions and organisations.
- Study and evaluate impact of new technologies on development and develop appropriate national responses in coordination with the relevant ministries, divisions and organisations.
- Facilitating capacity building of agencies involved in development.
- Any other function assigned by the Prime Minister.

PART-I Economic Wing & its Sections

There are nine Economic Sections in the Ministry. Out of which five Sections provide input/policy advice on economic policy of the country that cover areas like; macroeconomics, fiscal policy, international trade & finance, employment & research and poverty alleviation & SDGs. Coordination for formulation of short/medium/long term Plans and implementation of decisions of national fora like; CCI, NEC, Federal Cabinet and its Committees is carried out. Other four Sections work on Operations side and carry out functions of Public Investment Authorization, projects appraisal and approval, formulation of PSDP and release of development funds.



1. MACROECONOMIC SECTION

Section's Overview

The Section evaluates the macroeconomic situation and prepares macroeconomic framework for the country. In order to assess the economic performance, the Section keeps record of monthly macroeconomic indicators and prepares presentation for the Cabinet on monthly Key Economic Indicators to assist the Government in policy making decisions. Moreover, it produces Annual and Mid-year macroeconomic reviews. Overview of the Economy is given in **Box-1**.

Box-1: Overview of the Economy During 2020-21

- During 2020-21, the Government implemented well calibrated macroeconomic and social protection policies, which focused on balancing between protecting lives and supporting livelihood as the durable and orderly way of economic revival. As a result of Government's stimulus packages announced in the first quarter of 2020-21, the economy started to resume its pre-COVID growth recovery trajectory.
- From stabilization to accommodative fiscal and monetary policies helped in mitigating the economic fallout of the COVID shock and led the foundation of a V-shaped recovery. At a time when the developing world is grappled with rising debts, Pakistan's external debt recorded its slowest build-up of the last five years.
- With stable exchange rate, sufficient buffers in the shape of forex reserves, highest ever remittances, highest ever production level of two main food crops rice and wheat in a single year, highest ever LSM growth since 2005-06, lowest ever growth of total debt and liabilities in last 15 years, highest ever export growth since 2011, first current account surplus after 2011, and many other positives, the economy is set to take off for higher growth.

The Section produces Annual Plan Chapter on 'Growth, Investment & Savings'. It prepares Working Paper for the meeting of Annual Plan Coordination Committee (APCC) and Summary for National Economic Council (NEC) on review and outlook of the economy. The Section represents the Ministry on National Accounts Committee (NAC) of Pakistan Bureau of Statistics to finalise the National Accounts estimates



of the economy. The Section carries out sectoral analysis (agriculture, industry, services) of economy and develops growth targets for next year, fundamental for the Annual and Five-year plans. It prepares working papers for the meetings of Fiscal and Monetary Policies Coordination Board and the meetings of the Macroeconomic Working group.

The Section provides replies to National Assembly/Senate Questions, call attention notices and motions pertaining to growth, investment, economic development and frequently provides views/comments/ reviews to other Ministries/Divisions and organizations on macroeconomic issues.

Performance Review

During 2020-21, the Section performed following significant activities:

- Continuously monitored the performance of the economy from analytical perspective and produced 12 monthly presentations for the Cabinet on Key Economic Indicators (KEIs). Minister for PD&SI delivered these presentations.
- Mid-Year review of the economy was produced and was widely disseminated. Mid-year review is crucial for assessing progress and course correction of the economy.
- In order to finalise the Macroeconomic Framework (MEF) for 2021-22, the Section carried out consultations with SBP, Ministry of Finance, Ministry of National Food Security & Research (Mo NFS&R) and Ministry of Economic Affairs. Targets for the next year growth in different sectors were finalized in consultation with the stakeholders.
- Under the MEF, Medium-term Budgetary Framework and Annual Federal Budget is prepared by the MoF.
- The Section played pivotal role in formulation of Annual Plan 2021-22 and not only contributed chapter titled 'Situation of the Economy' but developed the executive summary of the Plan and ensured overall consistency of the document.



- The Section prepared the working paper (Part-I) pertaining to economic plan for 2021-22 and presented it to the Annual Plan Coordination Committee (APCC) for approval. The meeting discusses the contours of the economic and development plan for the next year with all stakeholders.
- Summary for the National Economic Council (NEC) on 'Review of Annual Plan 2020-21 and Proposed Annual Plan 2021-22' was prepared along with the presentation for the NEC which was delivered by Secretary Mo PD&SI.
- Being member of the National Accounts Committee (NAC), the Section participated in 103rd meeting of the NAC and worked closely with PBS in finalizing National Account estimates for 2020-21.
- Secretariat support for formulation of Three Years Rolling Growth Strategy was provided. The Section contributed draft of two initial chapters (Setting the Stage – 2008-18 and Outturns of Stabilization Policies during 2018-19 and 2019-20) of the proposed strategy. Work on the proposed strategy is underway and the Section is working on different assignments in this regard.
- Analysed the impact of Monetary and Fiscal Stimulus Packages for COVID-19. Moreover, replies to the National Assembly & Senate questions, motions and call attention notices were provided to the Assembly and Senate Secretariat. Views/ comments to Ministries/Divisions and other organizations on macroeconomic issues, material for budget speech, material for economic survey was provided.
- Provided working papers for the quarterly meetings of Monetary & Fiscal Policies Coordination Board, Macroeconomic Working Group and the Technical Group on Macroeconomic Issues.
- Apprised Sub-group of Planning Commission Advisory Committee on 'Economy & Finance' on macroeconomic issues twice during

2020-21. The sub-Group provided expert opinion on economy, which was compiled for policy insights.



- The Section is working on Macroeconomic Modelling and in this regard, data archives have been built on key macroeconomic indicators with annual, monthly and period average frequencies. Moreover, following tasks are under way; (a) assemble econometric estimates of various elasticities (both short & medium-term), (b) start building time-series database of sector-level output indicators, (c) fiscal policy indicators, and (d) external sector (i.e., balance of payments) with a detailed disaggregation of the trade sector.
- Worked closely with PIDE in finalizing themes for Demand Driven Research programme. In this regard, after several rounds of consultations a detailed engagement plan was finalized.
- Meticulously engaged with PBS in providing help for Change of Base exercise and for developing Quarterly National Accounts.
- Chief Macroeconomics gave a detailed presentation to Planning Commission on comparison of Macroeconomic Projections of Planning Commission and Dr. Hafeez Pasha.
- Worked on analysing *Ehsaas* interventions and their impact on inequality and poverty levels in the country.

2. MONEY, PRICES AND FISCAL POLICY SECTION

Section's Overview

Money, Prices and Fiscal (MP&FP) Policv Section. broadly deals with the matters relating to the analysis of fiscal developments, inflation, developments monetary capital and market development. Main functions assigned to this Section include the regular review/analysis of inflation, capital market developments, monetary developments and FBR's tax collection. Sectoral Overview is given in **Box-1**.

In addition, this Section is responsible for the analysis of the regional prices of the

Box 1: Sectoral Overview

- The total revenue remained 14.5 percent of GDP.
- Total expenditures remained 21.6 percent of GDP.
- Fiscal deficit remained 7.1 percent as compared to 8.1 percent during 2020-21.
- M2 witnessed growth of 16.2 percent growth.
- NFAs expanded by 5.6 percent growth.
- NDAs expanded by 11.9 percent growth.
- During 2020-21, average inflation remained lower than the previous fiscal year. Average CPI was recorded at 8.9 percent as compared to 10.7 percent in 2019-20.
- Core inflation remained stable as an increase of 6.7 percent on YoY basis was witnessed in June, 2021.

critical consumer items for National Price Monitoring Committee (NPMC) chaired by the Finance Minister. Other functions include the projection for inflation for Medium-Term Economic Framework, preparation of material for Fiscal & monetary Policies Coordination Board's meetings, dealing with National Assembly and Senate Business, provision of comments for ECC summaries and other relevant tasks assigned.

Performance Review

This Section produced reports on monetary, fiscal and capital markets development on regular basis along with the comments on the



summaries by the ECC. This Section produced reports on CPI and SPI for regular monitoring of the prices in the country and make relevant recommendations. More importantly this Section provided the regional price comparison to the National Price Monitoring Committee (NPMC) for discussion on the forum. In this regard, this Section actively coordinated with the foreign mission abroad for the provision of price data for regional price comparison.

This Section prepared working papers for Monetary & Fiscal Policies Coordination Board, regarding agenda items pertaining to the M/o PD&SI. This Section convened a meeting on the issue of inflation with all stakeholders where issues on measures to control inflation, price fixation and standardization were discussed. This Section participated in a meeting convened by PBS on the methodology of calculation of CPI.

Major Activities

In line with the above-mentioned tasks and mandate of the MP&FP Section, following major activities were carried out during 2020-21:

Reports on CPI and SPI

During 2020-21, twelve monthly reports on review of inflation and trends in Consumer Price Index were prepared. Further 24 weekly reports on changes in SPI for 51 essential commodities were prepared during the year. During 2020-21, average inflation remained lower than 2019-20. Average CPI was recorded at 8.9 percent as compared to 10.7 percent in 2019-20.

Reports on Monetary Development

This Section prepared 12 monthly reports on analysis of monetary developments, outlining changes in stocks of broad money (M2) and factors affecting M2 like Net Foreign Assets (NFA), Net Domestic Assets NDA), government borrowing for budgetary support and commodity operations, policy rate and its impact on offtake of private sector credit and inflation outlook.

Reports on Capital Markets

This Section prepared 12 monthly reports on review of capital market developments presenting trends of Pakistan Stock Exchange indices and comparison of major stock indices in the world. Further 12 monthly reports on portfolio investment, foreign direct investment, repatriation of profit / dividend on foreign investment and market capitalization were prepared. During 2020-21, Pakistan Stock Exchange depicted an overall upward trend and impressive performance for the time period Jun 2020- Jun 2021. The benchmark KSE-100 Index grew by 20.62 percent (8,097.58 points) with a remarkable consolidated average of 43,081.87 points.



5. POVERTY ALLEVIATION AND SDGs SECTION

Section's Overview

The major functions of the SDGs Section are poverty estimation and coordination for mainstreaming and achieving SDGs in Pakistan. The mission of the Section is to strive for a society where vulnerable and marginalized segments would be protected and encouraged by revamping and expanding social protection systems and social safety nets.

Major Activities

The Section performed the following major activities during 2020-21:

First Meeting of the NEC Sub-Committee on SDGs

The first meeting of the Sub-Committee of NEC on SDGs was convened on January 20, 2021. The meeting was instrumental for finalizing the baselines and targets, firming up provincial frameworks and better cross-sectoral and inter provincial coordination.





Poverty and Inequality Estimation

The Section estimated the incidence of poverty based on Cost of Basic Needs (CBN) approach using the microdata of HIES 2018-19. The Poverty Estimation Committee reviewed the estimates and provided their feedback in explaining the changes in the poverty situation in the country over the years. According to the latest published estimates, 21.9 percent of the population lived below national poverty line in the year 2018-19.

Comparing with 2015-16, CBN based poverty headcount has declined by 2.4 percentage points. This decline has been observed both in rural and urban areas, however the decline was more pronounced in rural poverty than in urban poverty (**Figure 1**).





Mid-Year Review Meeting of National Initiative of SDGs

Secretary PD&SI chaired a meeting to review progress on the National Initiative for SDGs on 22nd September 2020. The project is being executed jointly by the M/o PD&SI & UNDP. The meeting discussed progress of the project.


Implementation of *Ehsaas* Programme Initiatives

Under *Ehsaas* poverty alleviation programme, following three initiatives have been assigned to SDG Section, M/o PD&SI:

- Initiative #5, Pro-poor goals and measurable indicators for every ministry: To implement this policy statement, extensive coordination and consultations on pro-poor, goals of each ministry were conducted. Pro-poor goals of Federal Ministries have been shared with Poverty Alleviation & Social Safety (PASS) Division for periodic monitoring. The task stands completed on part of the M/o PD&SI.
- Initiative # 10, A Committee on Innovative Financing and deployment of innovative financing mechanisms to mobilize additional resources and create fiscal space for pro-poor investments and save government money earmark for pro-poor projects and programmes was constituted and working for the purpose. Under this initiative, 9 sub-committees were constituted on Social Sector, Infrastructure Development, Water and Sanitation, Tourism, Skill Development, Private Sector and Entrepreneurship, Climate Change and Disaster Management, Microenterprise Financing and Regulations. Reports of the subcommittees are awaited.
- Initiative # 12 Mandatory Section in the PC-I Performa to screen impact of PSDP projects on poverty & equality and on other SDG achievements": Under this initiative, a check list has been prepared to track the flow and alignment of development funds of various development projects with SDGs. The checklist was approved by the CDWP. This check list will become part of each PC-I and will help in tracking the impact of development projects on poverty.

Implementation of the SDGs

- Pakistan hosted the inaugural meeting of SAARC Planning Ministers on the theme 'Achieving the Sustainable Development Goals (SDGs) in South Asia: Shaping SAARC Vision 2030'.
- Analysis of ADP and PSDP was carried out and a consolidated report was prepared for the last three years (2017-2019) showing a trend analysis of budgetary allocations against SDGs.
- SDGs Pulse/ SDGs Dashboard Portal contains data on all

the available SDG indicators as well as updated value of SDG index.

- A training session on SDGs Dashboard Portal was held on 21st August 2020. Officers from this Ministry from SDGs Section, SDGs Unit and other Sections of the ministry attended the training. A Training manual has been developed for use of the different modules of the dashboard.
- SDGs Index for Pakistan has been developed and integrated in SDGs Dashboard.
- A couple of meetings were held with National Parliamentary Task Force for the development of SDGs scorecard at district level.



- Monitoring & Evaluation capacity assessment tool is developed while a framework for policy monitoring for SDGs, development, non-development and other projects was prepared.
- SDGs National Communication Strategy has been designed and disseminated. Identification of the target audiences through the social platforms and ministry level initiatives for advocacy have been added into the communication strategy.
- First SDGs snapshot report has been finalized for publishing.
- In the first phase, almost 40 universities were engaged for alignment of research with SDGs; introducing sustainability credits by encouraging students for community service and regional consortium and collaborations among universities for knowledge sharing and localizing SDGs.
- Printing & publishing of research studies, including annual report 2019, were printed this year and circulated to the relevant stakeholders.
- WHO Guidelines of COVID19 were translated into Braille and Sign Language.
- Federal SDGs Support Unit, in collaboration with ILO, has developed a dashboard on SDGs Indicator 1.3.1 based on detailed data mapping and consultation. This will become part of the SDGs Dashboard portal.
- Draft recommendations of the sub group on Poverty and Social Protection under the Chairmanship of Dr. Amjid Saqib were presented to the Minister for Planning. Several meetings were convened with the members of sub group during April-June 2021 to frame recommendations on improvement in Social Protection Programmes that help in alleviating poverty.
- A round table discussion on migration data management practices for SDGs achievement in Pakistan was organized on April 29th, 2021 in partnership with International Organization for Migration (IOM) and UNDP Pakistan chaired by Chief Economist, M/o, PD&SI. Representatives of UNDP Pakistan, Ministry of Foreign Affairs, Ministry of Interior, NADRA, Ministry of Overseas Pakistanis and Human Resource Development and



the Ministry of States and Frontier Region attended. The objective of the discussion was to understand the data collection mechanisms of different stakeholders related to migration data in Pakistan. The discussion revealed the importance of developing a homogenize definitions of key terms around migration and need for increased coordination among stakeholders. It was decided that IOM and Federal SDGs Unit will jointly organize meetings on Migration Data Management in Pakistan, providing opportunity to each stakeholder to present on current practices of data management and challenges that need to be addressed in order to ensure that the contribution of migration to SDG's achievement is adequately captured.

 A simulation exercise was carried out to assess the possible impact of COVID-19 on poverty incidence and the expected impact of cash transfers on lowest deciles of the household. The result of this simulation exercise was published in Chapter-1 of the Annual Plan 2021-22 (<u>https://www.pc.gov.pk/uploads/annualplan/ Annual Plan 2021-22.pdf</u>).

6. PUBLIC INVESTMENT PROGRAMMING SECTION

Section's Overview

28

The Section focuses on harnessing the value of public investment through formulation of Public Sector Development Programme (PSDP),

ensuring availability of funds, projects regulations and managing foreign assistance.

Accordingly, keeping in view this mission, effective allocations and releases of public investment to public sector projects with a view to optimizing value of money. lt coordinates and provides secretariat services for PSDP+ initiative PSDP proceedings.

Box-1: PSDP Formulation Process

PSDP is prepared in consultation with all stakeholders to achieve the development objectives set under the development plans. M/o PD&SI is mandated to coordinate formulation and implementation of PSDP. During the formulation process, the projects are proposed by the sponsoring Ministries / Divisions / Agencies within the Indicative Budget Ceilings (IBCs) issued by the Finance Division. The project-wise proposed PSDP is processed for approval through competent fora like; Priorities Committees of the Finance Division, APCC, NEC and finally by the Parliament along with Finance Bill each year. Only approved projects by the competent fora like DDWP, CDWP and ECNEC are considered for budgeting in line with provisions of PFM Act 2019. The recommendations of the Senate and National Assembly Standing Committees are considered by the respective sponsoring Ministries/ Divisions while proposing the development portfolio.

formulation process is given in **Box-1**.

Performance Review

In line with the assigned function, the Section processed the Federal PSDP 2020-21 which was approved by the NEC on June 10, 2020 at a size of Rs. 650 billion including foreign assistance of Rs. 72 billion. It was designed with a particular focus on strengthening the health sector and creating livelihood activities to fight widespread disruptions caused by COVID-19 pandemic besides upgradation of required physical infrastructure. Notwithstanding the rising spending requirement on recurrent side, the Federal government remained committed to



maximum utilization of allocated development funds under PSDP. The requirements of both on-going projects and emerging needs were appropriately catered for by allocating necessary resources especially for lagging areas including Merged Districts of KP and priority/high impact projects.

The sectoral position of PSDP 2020-21 of Rs. 650 billion is given in Table-1.

Major Activities

The Section performed the following major activities during 2020-21:

Release authorization of PSDP 2020-21

Ministry took several steps in consultation with Finance Division and with the approval of ECNEC to simplify and streamline development procedures. These steps include:

- The release procedure Flexible quarterly releases were set @ Q1:20 percent, Q2 & Q3: 30 percent each and Q4: 20 percent of allocated rupee budget, Ministries/Divisions/Agencies were however, empowered to release funds as per requirement of projects within the permissible quarterly ceilings.
- PSDP authorized releases were exempted from ways & means clearance from Finance Division as well as endorsement of sanctions.
- Principal Accounting Officers were empowered to open/manage the affairs related to projects Assignment Accounts through Asaan Assignment Account procedure notified by MoF, Delegation of powers for re-appropriations to the Secretaries/PAOs without referring cases to Finance and Planning Divisions to expedite spending and timely completion of the projects.

Quarterly reviews of PSDP 2020-21

Quarterly reviews of PSDP 2020-21, chaired by Deputy Chairman Planning Commission were arranged in order to asses physical and financial progress. First Quarter Review of PSDP 2020-21 was held during October, 2020. Likewise, Mid-year Review was held in February-March, 2021 to address the issues in implementation and to ensure full utilization and efficient implementation of PSDP. The performance of all Ministries / Divisions was categorized critically in terms of utilization of funds, number of completed projects, in-house monthly reviews of their respective portfolios and removal of outstanding bottlenecks for



smooth implementation of budgeted projects. Progress reports were inter-alia shared with the Prime Minister's Office.

Re-appropriation/adjustment in PSDP 2020-21

During quarterly reviews, Ministries/Divisions indicated savings from slow moving projects and M/o PD&SI allowed inter and intra sectoral re-appropriation / adjustment to the tune of Rs. 169 billion to meet additional demands of ongoing and new initiatives under PSDP 2020-21 like; Kamyab Jawan Programme, National Disaster Management Authority for Revival of 04 Nallahs/Rivers in Karachi, Karachi Coastal Power project, projects being executed by Pak-PWD, Ten Billion Trees Tsunami Programme, BECS and NCHD Programmes etc.

Due to concerted efforts, entire PSDP 2020-21 has been utilized and 217 projects costing Rs. 190 billion covering social as well as infrastructure sectors were completed which will generate benefits for the general public and help to alleviate impact of the prevailing COVID-19 pandemic in the country.

Foreign Aid Activities

Total size of PSDP 2020-21 of Rs. 650 billion including Rs. 72 billion as foreign aid. During the year, foreign aid disbursement was tracked on monthly basis. An amount of 126.8 billion were released and disbursed up to June 2021 against Rs. 72 billion which is 175 percent. About 39 concept clearance proposals were received and processed out of which 25 proposals were approved by the CDWP/CCC. During 2020-21, the Section participated in 09 (nine) meetings, held in EAD and provided required input related to foreign aided projects for finalization of revised estimates for 2020-21 and budget estimates for 2021-22. Prepared a number of donor-wise briefs for consumption at higher level meetings with the donors.



Coordination of PSDP + Initiatives

To reduce the burden on government exchequer, the present government has introduced PSDP plus initiatives by providing conducive regulatory and policy framework. Accordingly, Public Private Partnership Authority (P3A) was established in 2020 for this purpose. P3A has been mandated at federal level to make concerted efforts for fetching maximum funds under innovative financing modes. P3A currently has 50 projects at various stages of processing with an aggregate value of about Rs. 1 trillion covering Railways, Roads, Logistics, Science & Technology, Water, Aviation and Health etc. Two complex and high impact transactions worth Rs. 233 billion namely Sialkot-Kharian and Sukkur-Hyderabad motorways were processed in record time. Another six high-impact transactions, with a value of Rs. 710 billion are likely to be approved during 2021-22. The Government will provide VGF to make these projects viable in PSDP 2021-22.

Formulation of PSDP 2021-22

The Section processed the Federal PSDP 2021-22 which was approved by the National Economic Council (NEC) on June 07, 2021 at a size of Rs. 900 billion with focus on consolidation of development portfolio along with initiation of Regional Equalization Programmes like i) Accelerated Development Plan for Southern Balochistan at an estimated cost of Rs. 601 billion for execution of 199 projects, ii) Karachi Transformation Plan (KTP) costing Rs. 739.2 billion, iii) Socio-Economic Development of Gilgit Baltistan costing Rs. 179 billion, iv) Development Plan for 14+ Priority Districts of Sindh costing Rs. 29 billion to bring change at grassroot level, and v) Newly Merged Districts of Khyber Pakhtunkhwa to bring them at par with other parts of the country.

Other Activities

Detail of other activities performed by the Section during 2020-21 is given below.

- Representation on Standing Committees in Senate and National Assembly etc. with regard to PSDP matters.
- Prepared replies/reports/briefs for the Senate and Assembly Business including starred/un starred questions etc.
- Attended National Assembly and Senate sessions regarding budget sessions and other related matters.
- Furnished comments on PC-Is, on requirement from investment programming point of view.
- Arranged and coordinated review meetings on PSDP+ Initiatives.

- Formulation of guidelines/instructions for proposed PSDP 2022-23.
- Conducting comprehensive Full Year Review of PSDP 2020-21 (30-08-2021 to 15-09-2021).
- Conducting quarterly reviews of PSDP 2021-22.
- Punching of release sanctions into SAP system and updating/ tracking expenditure on daily basis.
- An exercise of Rationalization of PSDP 2021-22 is in progress.
- Addressing issues of ongoing and other PSDP projects.
- Participating meetings in respect of PSDP projects including Foreign Aided projects.
- Coordinating in respect of PSDP+ with Prime Minster Office as well as other Ministries/Organizations.

7. PUBLIC INVESTMENT AUTHORIZATION SECTION

Section's Overview

34

The PIA Section acts as a gateway for development projects in Planning Commission and provides secretariat services for the CDWP meetings. The Section processes PC-Is/PC-IIs of development schemes for consideration/approval of CDWP/ECNEC. The Section issues minutes/decisions of the CDWP to all members and sponsoring agencies as well as follow up with the relevant Technical Section for submission of summaries for consideration of ECNEC. The Section coordinates with the Cabinet Division for holding meetings of the ECNEC, after approval of development projects by the CDWP and ECNEC, authorization letters are issued by this Section.

The concept proposals of projects received from different sponsoring agencies from Federal and provincial Governments for foreign funding through EAD are placed by this Section before the Concept Clearance Committee.

In addition to the above, the policy and procedural matters relating to the processing of development projects are being dealt by PIA Section. The cases for enhancement of sanctioning powers of various development fora are being undertaken by PIA Section. The Section provides advice to Ministries/Divisions and Provincial Governments on the development procedures.

Performance Overview

The Section during the period from 1st April, 2020 to 31st March, 2021, conducted 27 meetings of CDWP wherein 170 projects were considered. Out of which 116 projects were approved and 37 projects recommended for consideration/approval of ECNEC being a competent forum for such projects. Additionally, the Section facilitated the Cabinet Division in the conduct of ECNEC meetings. During the reporting period, the 06 meetings of the ECNEC were held whereby 37



projects were approved. The total cost of approved projects by CDWP and ECNEC remained Rs. 366.15 billion and Rs. 1339.30 billion respectively. The sector-wise break up of approved projects by the CDWP and ECNEC is given in **Table-1**:

Moreover, 33 concept clearance proposals were accorded approval by the CDWP/Concept Clearance Committee during the same period. The following two documents were being prepared for perusal and information of the NEC:

- Progress report of the CDWP (1st April, 2020 to 31st March, 2021).
- Schemes approved by the CDWP and ECNEC.



Major Activities

In addition to its routine functions, this Section rigorously followed up with all concerned quarters for compliance of the CDWP and ECNEC decisions. Extensive consultations/follow-ups were carried out with the technical Sections of the Ministry for compliance with the directions of the DCPC, issued during the reporting period for effective execution of development projects.

The Section tendered comments on behalf of this Ministry on various policy issues relating to development projects being submitted to the Prime Minister by different Ministries/Divisions, besides tendering advice to the Ministries/Divisions on policy matters relating to development projects.

The Section being the secretariat of the DDWP of this Ministry convened seven meetings of the DDWP.

Other Activities

In pursuance of the ECNEC approved recommendations on the summary submitted by this Ministry regarding, "Simplification of Planning Commission/Planning Division Development Processes/Procedure to Improve Project Management" the Section followed up with line Ministries/Divisions for implementation and formulation of policy and procedures concerning development projects.

The Section drafted notification for formulation of the rules for implementation of the Public Finance Management Act, 2019 which is under final stages of approval after being considered by the CDWP.

The Section contributed and assisted in the formulation of the revised "Manual for Development Projects". In addition, the feedback to autonomous bodies was provided, regarding their development projects.



8. ECONOMIC APPRAISAL SECTION


Section's Overview

M/o PD&SI, as per the Rules of Business 1973, is responsible for the development of appropriate cost and physical standards for effective technical and economic appraisal of projects. The technical appraisal is undertaken by the concerned Technical Sections which covers engineering, commercial, organizational, environmental and managerial aspects whereas the financial and economic analyses (cost benefit analysis) of the projects are carried out by this Section. The appraisal of the development projects facilitates informed decision-making in selection/ approval of viable projects for socio-economic development of the country.

Performance Review

As reflected in **Box-1**, Economic Appraisal Section has undertaken financial and economic analysis (Cost-Benefit Analysis) of all the

projects included in the PSDP 2020-21 irrespective of sectors. The economic analysis of projects includes finding the Financial Internal Rate of Return (IRR), Economic Internal Rate of Return (EIRR), Benefit-Cost Ratio (BCR), Net Present Value (NPV) on the basis of Toll Rate, Subsidy etc. The adequacy of projects and risk if any, associated with it were also




assessed which facilitates informed decision making in selection/approval of viable projects for the socio-economic development of the country. The quality of the analysis depends on the quality of data and forecasts made about cost and benefits.

Major Activities

The Section performed the following major activities during 2020-21:

- Cost-Benefit Analyses of 305 development projects in various sectors of the economy was carried out and requisite input was provided to relevant forum such as CDWP and ECNEC.
- After enhancement of sanctioning powers of DDWP of Ministries/Divisions from Rs. 60.00 million up to Rs. 2,000 million in September, 2019, Cost-Benefit Analyses of about 700 development projects of various sectors pertaining to Ministries/Divisions were undertaken and 115 DDWP meetings were attended, as permanent member of all DDWPs.
- In addition, projects pertaining to AJ&K DWP were examined and requisite input provided in the relevant forums as Member.
- Furthermore, this Section participated in 55 pre/post CDWP meetings.
- Comparison of Appraisal of Development Projects through CDWP/ DDWP by Economic Appraisal Section during 2019-20 and 2020-21 is in **Figure-1**.





Other Activities

Detail of miscellaneous activities performed by the Section during year 2020-21 is given below:

- The Section actively participated in review meetings of the PSDP+ held on quarterly basis and input was provided wherever required.
- Various Committees have been formulated by the CDWP and Economic Appraisal Section has been nominated as Member of the Committees.



9. PLAN COORDINATION SECTION

Section's Overview

The Plan Coordination (PC) Section coordinates for preparation of short, medium- and long-term Plans for the country. Year Book of the Ministry is prepared by the Section. The PC Section coordinates in convening the Annual Plan Coordination Committee (APCC) and NEC meetings. The Section coordinates and follows up the implementation of decisions of Council of Common Interests (CCI), NEC, Cabinet and its different Committees including ECC, and Secretaries Committee. Directives of the President's Secretariat/ Prime Minister's Office are dealt by the Section. In addition, the Section prepares periodic performance reports of the Ministry, Budget Speech, Annual Report on Performance of NEC, Annual report on observance of Principles of Policy, etc. Moreover, meetings of high-level fora like Planning Commission, Advisory Committee of Planning Commission are organized by PC Section.

Major Activities

The Section performed the following major activities during 2020-21:

Formulation of Annual Plan 2021-22

On the basis of different sectoral reviews and outlook received from different Economic and Technical Sections of the Ministry, a thematic Annual Plan 2021-22 (focusing on sustainable growth in the backdrop of stabilization of the economy) was prepared. The Plan approved by the NEC on 7th June, 2021 was published and circulated to all key stakeholders i.e., National Assembly, Senate, Cabinet, Federal Ministries/Divisions, Provincial Governments etc. for implementation. First time in the history of the Ministry, the executive summary of the Plan was translated in Urdu also.



Annual Plan Coordination Committee (APCC)

The APCC builds consensus on Annual Plan 2021-22 and PSDP 2021-22 documents prior to sending it to the NEC for approval. Meeting of the

forum organized on 28th May, 2021 was chaired by Deputy Planning Chairman Commission and was attended by Provincial Finance Planning & Ministers. Federal other Secretaries, Provincial



representatives and Heads of different Public Sector Enterprises. State of economy comprising review of 2020-21 and outlook of macroeconomic framework for 2021-22 was presented. Finance Division and State Bank of Pakistan gave their views on the stance of M/o PD&SI. The PSDP allocations proposed for 2021-22 to complete development agenda of Ministries/Divisions in the light of physical/financial progress of PSDP 2020-21 were discussed and agreed upon.

NEC

Proposed agenda of the NEC meeting scheduled on 7th June, 2021 along with working paper/summaries was shared with the Cabinet Division.

Year Book 2019-20

In compliance of Rule 25 of the Rules of Business 1973 and guidelines of Cabinet Division, the Year Book 2019-20 was prepared. The Book contains the details of activities, achievements and progress of various Sections/wings/attached departments of the Ministry during 2019-20. The 38 chapters received in PC Section were reviewed by the Committee headed by JCE (Ops). Reviewed version was edited by PC



Section and formatted by JACC. After approval of Secretary PD&SI, the Book was published online on the Ministry's website.

Advisory Committee of the Planning Commission

For better policy making in wake of the emerging development challenges to the economy a forum of Advisory Committee was constituted by the Government. PC Section acts as a Secretariat of Advisory Committee. Two meetings of Advisory Committee were organized under the chairmanship of Minister for PD&SI during 2020-21.

Meetings of the Planning Commission

Planning Commission is headed by the Prime Minister of Pakistan whereas due to his heavy engagements, the Deputy Chairman oversees the day to day functioning of the Commission. The DCPC is assisted by 12 Members whereas Secretary PD&SI is Member Coordination of the Planning Commission. Three meetings of Planning Commission were organized by the Section during 2020-21 and the decisions taken in the meetings were followed up for their implementation.

Other Activities

- Coordinated for compilation of material for Finance Minister's Budget Speech taken from different Sections/Wings of the Ministry and the information was compiled and furnished to Ministry of Finance.
- Comments/inputs on Draft National Domestic Commerce Policy 2021-25 from all the Sections/Wings concerned of the Ministry were collected, consolidated and furnished to Ministry of Commerce.
- Follow-up action on decisions of the CCI, NEC, Cabinet and Cabinet Committee on Privatization (CCOP), Cabinet Committee on Investment (CCOI), Cabinet Committee on CPEC (CCOCPEC), etc. and ECC was taken up and progress on implementation was reported to the Cabinet Division.



- Briefs for Deputy Chairman Planning Commission and Secretary PD&SI were arranged for all the meetings of Cabinet, CCI, Committees of Cabinet and ECC.
- Coordination for preparation of Report on Two-Year Performance of the Government (Aug 2018-2020).

Work in Progress

- Coordination for preparation of Year Book for 2020-21.
- Coordination for preparation of Annual Report of NEC for 2020-21.
- Organizing meetings of the sub-committee of Advisory Committee under the chairmanship of Minister for PD&SI.
- Follow-up Directives of the President / Prime Minister.
- Coordination for implementation of decisions of NEC, Cabinet and its sub-Committees etc. and furnishing of the implementation status.
- Coordination for implementation of the decisions of the Planning Commission and organizing the meeting of the forum.

PART-II Technical Wing & its Sections

There are nineteen Technical Sections in the Ministry which cover various socio-economic areas of the economy including but not limited to science & technology, industries & commerce, devolution & area development, mass media & manpower, information & communication technology, transport & communication, physical planning & housing, energy, water, health, nutrition, food & climate change, social welfare etc. Mainly, these Sections are responsible for technical appraisal of development projects. Technical aspects like; engineering, commercial, environmental and managerial issues are examined. Technical Sections play an important part in informed decisionmaking for selection/approval of viable development projects for socio-economic development of the country.



1. FOOD AND AGRICULTURE SECTION

Section's Overview

The Food and Agriculture Section is entrusted to assist in planning for the development of agriculture including all its subsectors regarding production, values addition and value chain development. The Food and Agriculture Section is actively maintaining a close liaison with the

relevant ministry i.e. National Food Security & Research (Mo NFS&R), provincial departments as well as with the other development partner organizations, NGOs, etc. Section plays an active role in formulation of strategic framework and perspective plans along with identification of key investment areas in consultation with the stakeholders. Major functions of the Section include, budgetary progression, processing, appraisal and review of PSDP and donors funded projects. Provide inputs for Priorities Committee, APCC, NEC, Parliament Standing

Box-1: Sectoral Overview

Food Security of a country is ensured by growth in the various sectors of economy and most vital sector in ensuring food security is the sustainable development of agriculture sector including livestock, fisheries, forestry etc. The performance of the sector is dependent on the policies, development initiative undertaken by the government and trickling down of its benefit to the gross root farming communities. During 2020-21, agriculture sector has performed satisfactory by achieving the growth rate of 2.77 percent against the set target of 2.8 percent.

Committees, etc. Representation of ministry in various fora engaged in development process including IDWP, DDWP, PDWP, Pre-CDWP, CDWP and ECNEC. This Section is responsible for drafting relevant chapters for prospective plans including Annual Plan, Five-Year Plan, three-year growth strategy and Year Book. The Section prepares periodic performance reports, examines summaries for the ECC of the cabinet and prepares briefs on summaries of the Cabinet and the CCI. Keeps a watch on national food security situation including availability, accessibility, consumption, safety, quality and trade of food items along with supply demand situation of inputs for farming and food



production both at national and international levels. The overview of the sector is given in **Box-1**.

Performance Review

This Section provided active support during 2020-21 for inclusion of 36 development projects of MNFS&R in PSDP to uplift the agricultural economy include crops, livestock, fisheries and horticulture subsectors. Maximum number of the projects are underway to achieve objectives of enhancement of productivity, ensure food security, alleviate poverty in rural areas, contain import bill of food items and attain overall economic development of the country.

Workshops and consultative meetings were organized for the following national agendas and policy interventions/legislative interventions:

- Animal Health Control Act in line with OIE requirements.
- Developing National Project on Cotton Revival.
- A comprehensive study on Fertilizer Industry.
- Developing National Agriculture Research Agenda.
- Genetic Improvement of Livestock Breeds in Pakistan.



2. CLIMATE CHANGE AND ENVIRONMENT SECTION

Section's overview

The Section appraises and evaluates development projects PC-Is and PC-IIs of the almost every sector of the PSDP with environmental and

climate change sustainability lenses. In addition to appraisal of sector and sub sector of the PSDP schemes, various schemes are being supervised by this Section as technical Section to completely appraise the project as per the guidelines and standards of the Planning Commission. In addition to the evaluation process. formulation of master plan for each sub sector was worked in the 2020-21, with regard to implementation of the Climate Change Policy 2012. and subsequent Climate Change implementation framework in

Box-1: Sectoral Overview

The short-term vision of past practices has put tremendous pressure on the carrying capacity of environment in Pakistan. Recent impact of COVID has resulted into the further deterioration of living standard and quality of lives.

In order to break vicious cycle of poverty and pollution, Climate Resilient project are being considered in PSDP to keep up pace with changing National and International scenario. A total of Rs. 14.327 billion have been allocated to climate change sector and most of these funds have been allocated to Prime Minister's Ten Billion Tree Tsunami Programme.

Performance Review

This Section examined and processed new as well as revised development projects of M/o Climate Change, Interior, Aviation (CAA, ASF), Housing & Works (Pak. PWD), Maritime (GPA, PQA, KPT), M/o KA&GB (Gilgit Baltistan and AJ&K) and provincial Environmental projects, considered/approved by the relevant competent forums

During 2020-21, the sector was authorized Rs. 5.941 billion and Rs. 0.151 billion for Climate Change Division and Aviation Division respectively under the federal programme. Against this, an

expenditure of Rs. 5.93.741 billion and 0.297 billion was incurred by the end of the year respectively, giving an overall utilization of 99 percent and 52 percent respectively.

due to resource constraints two projects "Climate Adaptation and Resilience (CARE) for South Asia having cost of USD 36 million and Climate Risk Profile and Needs Assessment for Pakistan having cost of 0.3 million Euro were initiated with financing primarily by World Bank and GIZ, Germany, during 2020-21.

Major Activities

This Section provided technical assistance to the following projects:


- Ten Billion Trees Tsunami Program (TBTTP) project, with an allocation of Rs. 5942.715 million during 2020-21 wherein Rs. 3920 million have been released. Project titled as "Establishment of Pakistan WASH Strategic Planning and Coordination Cell with the cost of Rs. 40.000 million" is based to target Government's International commitments.
- Project namely "Climate Resilient Urban Settlement Unit with the cost of Rs. 56.825".
- Climate Adaptation and Resilience (CARE) for South Asia with cost of USD 36 million and Regional Integrated Multi-Hazard Early Warning Systems for South Africa and Asia (RIMES).
- Glacier Lake Outburst Flood-II (GLOF-II) with the cost of Rs. 3920.188 million" though Green Climate Fund (GCF) is being executed.
- Installation of Weather Surveillance Radar at Multan Rs. 1848.650 million.
- Reverse Linkage Project between Pakistan Meteorological Department and Marmara Research Centre (MRC), Turkey.

Section's overview

Nutrition Section works in line with the vision of a "Hunger free

Pakistan" and to ensure food and Nutrition security through cost effective nutrition interventions. The Section provides a platform for multi sectoral discussions interventions and for fulfilling national and international commitments for up nutrition. scaling of Nutrition awareness, advocacy and capacity building of relevant stakeholders have been

Box-1: Sectoral Overview

- Nutrition is a multi-dimensional subject which portrays its different aspects in many sectors like health, agriculture livestock, food, education, water, sanitation & hygiene and women development etc. It is directly linked to 12 out of 17 Sustainable Development Goals (SDGs) and generally marked as the maker and marker of all SDGs.
- Implementation of Pakistan Multi-sectoral Nutrition Strategy (PMNS) (2018-23) through the development of Nutrition Action Plan in collaboration with stakeholders i.e., health, education, food security, provincial relevant departments etc. is under process.
- SUN Movement Pakistan with its established networks will facilitate the relevant stakeholders for more focused interventions in nutrition sector.

nutrition and their role in nutrition scaling. The overview of the sector is given in **Box-1**.

Planning Commission Government of Pakistan joined the Global SUN movement in 2013. The SUN Secretariat is housed in Nutrition Section, Planning Commission being an apex body for policy, planning, coordination and monitoring and evaluation. This Section coordinates with the line Ministries and departments at the Federal and Provincial level for nutritional interventions in this regard.



Performance Review

The Nutrition Section engaged in the multi-sectoral stakeholders' coordination, collaboration, consensus building. To oversee progress of improving nutritional outcomes, two high level multi-sectoral nutrition governance structures have been established i.e.

- "Pakistan National Nutrition Coordination Council (PNNCC)" Chaired by the Honorable Prime Minister of Pakistan.
- "National Nutrition Forum (NNF)" Chaired by Deputy Chairman Planning Commission.

High-level decision-making nutrition for a together with provision of adequate and real time nutrition data will strengthen nutrition sector. Public-private partnerships, financing, and scale-up of nutrition programming will improve nutrition indicators.

Major Activities

- Multi-Sectoral National Nutrition Action Plan drafted to address all forms of malnutrition through short, medium- and long-term interventions and approaches.
- Early Childhood Development (ECD) policy framework has been formulated to focus on 1000 days window (conception to 2 years) of opportunity up to 8 years of age children. Mapping report and parenting package prepared & policy dialogue held.
- Data of "Food Composition Table (FCT) for Pakistan" analyzed and report drafted for having nutritional information on raw & cooked foods based on 12 agro-ecological zones.
- Pakistan Dietary Guidelines for Better Nutrition (PDGN) revised, launched and E-learning course launched for guiding masses to adopt healthy dietary behaviors and lifestyles.
- A livelihood project "Improving food security and nutrition, minimizing the impacts of covid-19 on livelihoods of poorest households in South Punjab (Bhakkar, Khushab and Mianwali districts)" with the financial assistance of International Fund for Agricultural Development (IFAD) has been prepared.

- Gwadar-Lasbela Livelihoods Support Project Phase-II (GLLSP-II) having nutrition component: Improving nutrition and food security through kitchen gardening, advocacy, awareness & capacity building in Gwadar and Lasbela districts of Balochistan has been approved and plan of action prepared.
- High-level Progress Review and Consultation on Global Action Plan (GAP) has been formulated with the support of development partners to accelerate progress in the prevention and management of child wasting through multisectoral interventions for achieving the SDGs.
- A fact sheet on "Socio Economic Impact of COVID-19 on Nutrition Sensitive Sectors in Pakistan" developed, printed and disseminated by Civil Society Alliance (CSA) of the SUN Movement in Pakistan for community awareness.
- Social Media Campaign on "Making Food and Nutrition Security: A Fundamental Constitutional Campaign" and a short film on the importance of nutrition "*Sehat ki Dastak*" developed and launched on YouTube and SUNCSA Facebook page.
- Nutrition Sensitive COVID-19 messages compiled, developed / adapted, translated in local languages, printed and shared on radio for mass awareness by SUNCSA.
- Webinars held with SUN Global headquarter Geneva on COVID-19, Young children amidst COVID-19: Exploring the power of play in building the resilience of young children and their families at home, Micronutrients in emergencies: How can we prevent an increase in hidden hunger, 2020 Hunger Report Launch: Better Nutrition, Better Tomorrow.

Appraisal of projects

The Section processed different schemes during 2020-21 through various approval fora i.e., CDWP and ECNEC as given in **Figure-1**.

Other Activities

Detail of other activities performed by the Section during 2020-21 is given below:

- A slot for "Nutrition Advocacy and Awareness Sessions" has been integrated into the regular training activities of PPMI, Planning Commission. A pool of nutrition experts has been identified for conducting the sessions in upcoming PPMI trainings on different nutrition topics for nutrition awareness and advocacy among the masses.
- Under the Food Fortification Programme for Wheat flour, Edible Oil & Salt, about 1006 wheat flour mills, 136 edible oil mills, 1100 small scale processors are providing iron fortified flour, vitamin A & D fortified oil and iodized salt.
- As a pilot project by SUN Business Network, a workplace nutrition plan has been designed and launched. The Network Translated the Global Workplace Nutrition Handbook into Urdu language for better understanding at local level.
- Scaling Up Nutrition (SUN) Pakistan Website has been launched for digital presence of nutrition information for masses and is regularly updated.



- National Nutrition Conference organized with the theme "Improved Nutrition – Secure Future" chaired by Honorable President Islamic Republic of Pakistan.
- Orientation and training of media persons conducted and policy dialogue held with parliamentarians on projecting the consequences of malnutrition and their role to address.
- Academicians and researchers from 41 Universities/research institutes were trained on research methodologies & technical report writing.
- Conducted webinar in collaboration with Global Health Advocacy Incubator & SUN Academia and Research on "Impact of Sugar Sweetened Beverages on Obesity and Non-Communicable Diseases".

Work in Progress

The Section is working on the development of new proposals/projects for nutrition security. The work on the development of concept note initiated for establishment of "National Nutrition Management Information System (NMIS)" to mitigate data gaps. A National Nutrition awareness campaign "National Nutrition Thought Management Programme (NNTMP)" with the objective to educate and sensitize all population groups through different multi sector opinionmakers/influencers is under pipeline.



4. HEALTH SECTION

Section's overview

Though the health sector devolved after stands 18th promulgation of constitutional amendment but this Section assists relevant stakeholders including M/o NHSRC and provincial health departments in defining national vision and strategic planning and policy formulation. The Section examines development portfolios of line Ministries/ Divisions including projects

BOX-1: Sectoral Overview

- COVID-19 pandemic affected lives as well as psychosocial and economic wellbeing of the people. Deficiencies of critical care health infrastructure and access to these facilities in remote areas surfaced. M/o PDSI conducted a nationwide Health Facilities Assessment (HFA) digital survey for upgradation and strengthening of Health Infrastructure in the country.
- Accordingly, federal govt. supported provincial health departments by providing funding of over Rs. 50.00 billion to 22 projects on matching grant basis.

Performance Overview

Performance overview of the Section is as follows:

Annual Development Plan

COVID-19 responsive Annual Development Plan 2020-21 was prepared with focus on various COVID-19 specific key interventions which included strengthening of hospital care by establishing fully equipped high dependency/ critical management units and infectious disease units at DHQ/THQs hospitals all over the country. A health up-gradation plan was rolled over during 2020-21. A proposal for establishment of public health laboratory network envisaged in the plan was approved for strengthening of public health disease surveillance system in the country.



Strengthening Civil Registration & Vital Statistics

The PC-I was approved by CDWP on 19 May 2020 at a total cost of Rs. 201.917 million with foreign Aid of Rs. 130.949 million for a period of 36 months. The project envisages achieving universal registration of all vital events (births, deaths, marriage, divorce etc.) in ICT model.



Mental Health and Psychosocial Support (MHPSS) Initiative

To steer and coordinate a mental health and psychosocial support (MHPSS) unit established in M/o PD&SI to cope prevailing COVID-19 outbreak with the aim to raise public awareness for psychosocial well-being of atrisk population and stigma prevention and discrimination



of infected population, with the engagement of multiple partners including Education, Health, Interior and Information Technology Ministries.

Major Activities

A detailed Health Facility Assessment Survey (HFA) was conducted by the Planning Commission all over the country to assess the critical needs of public health facilities in terms of manpower, medical



equipment and infrastructure. A total of 258 THQ hospitals and 101 DHQ hospitals were mapped and assessed for their preparedness vis-à-vis existing gaps, the results were shared with the provinces for preparation of component PC-Is under the approved umbrella COVID-19 Responsive and other Natural Calamities Control Programme with a total cost of Rs. 70.00 billion.

A total of 22 projects under the above umbrella PC-I were approved and financed under the programme. The detail is given in **Table-1**:

A national consultation on the status of nurses for the year 2020 was organized in January 2021 to consolidate national and provincial stocks of nursing education and capture the provincial initiatives undertaken in the past year for advancement of nursing profession. Multiple consultative meetings were organized with M/o NHSRC, PNC, HEC and provincial/area governments to revive nursing and midwifery profession in Pakistan so as to set practical and feasible manpower plans to address the critical nursing deficiency in the country. Appraisal of projects is given in **Figure-1**.

5. POPULATION & SOCIAL PLANNING SECTION

Section's Overview

62

The Population and Social Planning Section of this Ministry deals with demographic planning, facilitation and technical appraisal of PSDP projects on population welfare pertaining to federal M/o NHSR&C, Population Welfare Programmes of AJ&K and GB respectively. Besides the technical appraisal of PSDP projects, the Section also takes consultative role regarding initiatives on key interventions which are to be taken up as a priority by the provincial Population Welfare Departments. Population sector is a priority in the wake of COVID-19 to provide improved maternal health services, improvise service delivery disruptions and maintaining a readily available stock of commodities. In this regard, the Planning Commission played a stewardship role and assembled a consultative forum to advise and consult with the provinces regarding redressal of the challenges posed by the pandemic. Realizing that the genuine top-level commitment is imperative, the Planning Commission institutionalized the Population Situation Analysis (PSA) 2020 during the course of the year which is intended to yield high dividends in terms of outlining the existing population dynamics of the country.

Performance Review

The Section organized Dissemination Seminar on Population Situation Analysis 2020 in December 2020 where Hon'ble President of Pakistan was the Guest of Honour and Keynote speaker. The findings pertaining to PSA 2020 were shared with the participants of the seminar. As far as the PSDP is concerned, out of total allocation of Rs. 185.749 million, Rs. 55.731 million were utilized. Subsequently, the Population Welfare Programme, AJ&K (2017-20) has been completed while Population Welfare Programme GB (2017-20) has been given one-year extension. Moreover, PSDP scheme on Implementation of National Action Plan on Population was also approved by the DDWP at cost of Rs.1998.82 million.



Major Activities

The Section performed the following major activities during 2020-21:

Consultative Meeting on Population and Development

The Population Section organized the 3rd, 4th and 5th Consultative Meeting on Population and Development on 24th September 2020, 23rd December 2020 and 3rd March 2021. The consultative meeting series is an ongoing initiative to solidify the government's resolve to accord highest priority to population.

Dissemination Seminar on Population Situation Analysis 2020

The dissemination seminar of PSA 2020 was organized by the Section on 9th December, 2020 in collaboration with UNFPA, wherein the Honourable President of Pakistan was the keynote speaker. The Population Situation




Analysis (PSA) provided an integral appraisal of population dynamics, sexual and reproductive health, gender and youth issues and their relationship with social, economic, political and cultural processes in Pakistan.

Experts Policy Round Table on Population

An Experts Policy Round Table was organized by the Section on 16th March 2021, to engage private sector, development partners, donor agencies and academia to discuss the government's collaboration with private sector and development partners. in improving the efficacy of various interventions in the population domain.



Following two projects of special areas AJ&K and GB, funded through federal PSDP were in process of completion by the end of 2020-21. The Population Welfare Department (PWD) GB could not meet the targets and is given one-year extension and is expected to be completed by June, 2022. The provincial population sector programmes are being implemented under the ADP funding. The details are given in **Figure-1**.






In addition to the above projects, the M/o NHSR&C has sponsored a project titled "Implementation of National Action Plan on Population 2021-26" with a total cost of Rs. 1998.820 million. The allocation for the said project during 2021-22 is Rs. 250 million. The project was approved by DDWP on 28th May 2021.

Meeting of sub-group of Advisory Committee on Health and Population

Two meetings of the sub-group of Advisory Committee comprising of health experts from public and private on Health and Population were held on 25th March 2021 and 13th July, 2021. Opinions of the sub-group



Youth Priority Action Items (Reproductive Health and Population)

As part of the nation-wide consultative exercise on setting national youth priority action agenda, Planning Commission organized a dialogue on reproductive health and gender priorities with the support of development partners, to identify challenges confronting the youth of Pakistan today, and deliberating on possible solutions. High impact reform interventions have been included in the priority action agenda.

Social Sector Accelerator

The Social Sector Accelerator Programme (SSA) is an initiative of Planning Commission in order to have technical backstopping for planning, coordination and monitoring for essential technical components to

6. EDUCATION SECTION

Section's Overview

Education Section is tasked with preparation of Long/Medium/Short term Plan. It extends assistance to Ministry of Federal Education & Professional Training as well as other ministries in the preparation of Federal PSDP related to Basic and College Education. PC-Is & PC-IIs, Concept Clearance Proposals, Position Papers for education related development projects are appraised for consideration of DDWP, CDWP and ECNEC. Education Section provides support to Projects Wing for monitoring and evaluation of development projects, as well as technical reviews of education sector foreign funded projects held in

Economic Affairs Division (EAD).

Performance Review

In accordance with the functions of the Section envisioned in the Ministry's mandate, the Section during 2020-21 examined and processed both new and revised development projects of Ministry of Federal Education & Professional

Box-1: Sectoral Overview

- Education plays the most important role in the evolution of human progress and nation development. It provides people with vision, creativity and skills to meet the challenges of the time and contribute to socio-economic growth of the country. These objectives are achieved when equal opportunities of quality education are provided to all citizens without any discrimination of gender, age, region or ethnicity.
- Accordingly, projects included in PSDP 2020-21 aimed at introducing uniformity of curriculum, mainstreaming *Deeni Madaris*, capacity building of educational managers, initiating new trends of teaching/ learning, establishment/ renovation & up-gradation of schools and colleges to provide quality education, enhance access and remove gender disparities.

Training, Ministry of Defence and Finance Division.

During 2020-21, the sector was provided Rs. 8028.437 million for different development projects related to Basic and College Education. The Sectoral Overview is given in **Box-1**.



Major Activities

The Section performed the following major activities during 2020-21:

COVID-19 responsive Education Sector Projects

In order to meet the challenges posed by COVID-19, two projects sponsored by Ministry of Federal Education & Professional Training (FE&PT) were processed by Education Section and approved by CDWP on 21-10-2020. They are "Pandemic, Response Effectiveness Project (PREP) for COVID-19" and "Response, Recovery and Resilience in Education-Programming in Post COVID-19 in Pakistan". The objectives of these projects are to provide students with distance learning opportunities through TV / radio broadcast and virtual networks of teachers.

Advisory Committee on Education & Training

Being a Secretariat of Sub-Group of Advisory Committee of Planning Commission on Education & Training, Education Section arranged initial meetings of the Sub-Group and gave it a briefing regarding on-going development projects of education sector. M/o PD&SI constituted the Technical Working Group on Education and Skill Building to consult and propose high impact priority interventions to improve youth education indicators, in tandem with the nationwide consultations to set the National Youth Priority Action Agenda as per the Ministerial Directive. The priorities are part of the youth development investment case.

Annual Plan & Pakistan Economic Survey

The Section prepared chapters on Basic and College Education for Pakistan Economic Survey 2020-21 and Annual Plan 2021-22. Sectoral priorities for next 1-3 years were finalized in consultation with the Ministry and sectoral experts, and listed as Government priorities and targets for the next year 2021-22. This exercise was useful in preparing quarter wise targets for inclusion in Performance Contract Agreement




for 2021-22 & 2022-23. The targets include tangible activities to be carried out by Education Section in the next two years.

Other Activities

The detail of other activities performed by Education Section during 2020-21 is as under:

- Participated in the preparation of PSDP 2021-22 related to Basic and College Education during the last quarter of 2020-21.
- Appraised 05 DDWP level projects and presented the views of Education Section during DDWP meetings of line ministries. Details given in **Figure-1**.

- Arranged 17 Pre-CDWP and 1 Post-CDWP meetings to review the projects and give technical support to sponsoring agencies before presenting the projects to CDWP forum.
- Attended review meetings of PSDP held on quarterly basis and gave input wherever required.
- Offered comments to PIP Section for release of funds and re-appropriation cases.
- Arranged 7 consultative meetings with sponsors to provide them with technical support regarding projects.



Work in Progress

- The Section is working on the drafting the High Impact Strategic Interventions (HISIs) for improvement of Basic and College Education in the country. The Section is actively working on the preparation of key interventions/proposals for projects on PPP mode.
- Under the directions of PM office, the Section is coordinating with provinces to finalize the design for primary container schools to provide easy access to students at their doorstep. Besides, the work on the issues of out of school children and female students' enrolment/retention will be in progress during 2021-22.



7. SOCIAL WELFARE SECTION

Section's Overview

Social welfare sector aims at making development inclusive that provides equal opportunities of development to the marginalized segments of the society. In this regard, Ministry of Human Rights (MoHR) and Poverty Alleviation & Social Safety Division (PASSD) programmes initiate various initiatives, develop and implement projects, design and implement interventions as part of their regular activities as well as part of PSDP. This Section provided technical support for such initiatives/programmes.

Performance Review

Performance overview of the Section is as follows:

PSDP 2020-21

In the PSDP 2020-21, an amount of Rs. 256 million was allocated for 14 projects of Ministry of Human Rights, of which, eight projects were ongoing and six new.

Inclusion of Disability Check List in PC-1

A Disability Friendly PC-I Checklist has been drafted which was discussed by the CDWP. CDWP has directed to hold national and provincial consultation for its finalization. The draft has been updated by including the components of accessible infrastructure,



transportation, communication, emergency excavation and five generic questions to be taken into consideration for evaluating the PC-I from disability perspective. World Health Organization, being part of



the Technical Advisory Group on Disability Friendly PC-I Checklist, is providing technical assistance for national and provincial consultations with key stakeholders. The first consultative workshop at federal level was held on 15th March, 2021 in Islamabad. Provincial consultations will be organized in 2021-22.

Policy Dialogues on Youth Action Prioritized Agenda

In tandem with the nationwide consultations with provincial governments, academicians and youth representatives to set the national

youth priority action agenda, a national policy



dialogue for mainstreaming youth with disabilities was organized under the supervision of Member (Social Sector & Devolution), Planning Commission. Two consultative meetings on integration of gender in youth development initiatives were organized as part of the larger nation-wide consultation to inform the National Youth Priority Action Agenda.

Establishment of Social Sector Accelerator

The PC-I for Social Sector Accelerator was approved at an estimated cost of Rs. 350 million and included in PSDP 2021-22.

Citizen Complaint Portal

Social Welfare Section processed and resolved 185 complaints related to the social welfare issues received on the "Citizens Complaint Portal".



Operational and Technical Reviews

Quarterly review of the PSDP 2020-21 projects and some out-of-development budget initiatives were conducted.

During the year, the Section has processed 20 PC-Is for consideration in PSDP 2021-22 and four Concept Clearance Proposals for foreign funded programmes through budgetary support.

8. DEVOLUTION AND AREA DEVELOPMENT SECTION

Section's Overview

Devolution and Area Development Section is the focal point to deal with development activities related to less developed and Special Areas

The Section appraises and evaluates development projects/ PC-Is of the multisectoral schemes, foreign funded projects in less developed areas of four provinces and

Box-1: Sectoral Overview

- Less developed special areas are blessed with plenty of natural economic potentials that can be utilized to accelerate development in these areas. Federal government is making every possible effort in collaboration with local administration of these areas to fully utilize development potential of these areas and bring less developed areas at par with other parts of the country.
- Federal government has, therefore, taken measures through providing block allocations during 2020-21, for AJ&K, Gilgit Baltistan and merged districts of KP, including allocation for 10-year development plan. These were in addition to federally funded schemes.

two special areas, and advises & facilitates the relevant line Ministries/ Departments to accelerate development in these areas. Overview of the sector is given in **Box-1**.

Performance Review

During 2020-21, the sector was provided an amount of Rs. 87.5 billion as block allocations for three less developed special areas, including Rs. 24 billion for 10-year development plan for merged areas of KP. These funds were provided through respective Ministries/Divisions. In line with the functions of the Section development activities in less developed areas were coordinated with line Ministries /Divisions i.e. M/o Kashmir Affair & Gilgit Baltistan, M/o Interior and P&D departments of AJ&K, Gilgit Baltistan and Khyber Pakhtunkhwa.

Projects/programmes have been implemented through respective ADPs of special areas. Through Gilgit Baltistan ADP-2020-21, a total number of 1,712 development projects have been implemented. Out of these, 1,266 were on-going, 446 were new and 347 have been completed by June 2021. In AJ&K-ADP-2020-21, a total number of 581 schemes have been implemented. Out of these, 391 are on-going, 190 are new and 199 have been completed by June 2021 in various sectors. Merged districts of KP ADP-2020-21, included a total number of 828 schemes, including 806 on-going and 22 new schemes. These schemes are aimed at improving the living standard in less developed special areas.

A comparison of special area's PSDP block allocations during 2020-21 and 2021-22 is given in **Figure-1**.




Figure-1: Comparison of Special Areas Block Allocation 2020-21 & 2021-22

Mass Media Section formulates policies, plans and programmes for development of broadcasting networks and programme production

The main objective was extending TV signals to remote and left out pockets of the country, upgrading of satellite broadcast from SD to HD and digitalization of terrestrial network of PTVC. Different projects for achieving above remained in progress during the year 2020-21. Similarly, work on projects envisaging the extension of radio signals to AJ&K and Gwadar as well as for achieving the cross-broader access remained in progress during 2020-21. Moreover, a strategic plan for migration of radio broadcasting to digital was prepared.

additional responsibilities and prepare policies, plans and programmes for conservation of cultural heritage, development/ strengthening of new and existing sports facilities, harnessing the tourism potential of the country. The Section is looking after the administrative matters of Development Communication Project. The overview of the Sector is given in **Box-1**.

Performance Review

During 2020-21, the Section appraised and processed the approval of a number of new and revised PC-Is/PC-IIs of Information & Broadcasting Division, National Heritage & Culture Division, Ministry of Inter-Provincial Coordination (IPC), Cabinet Division and their attached departments including Pakistan Television Corporation (PTVC), Pakistan Broadcasting Corporation (PBC), Pakistan Sports Board (PSB), Pakistan National Council of Arts (PNCA), Pakistan Academy of Letters



(PAL), National Institute of Folk and Traditional Heritage/Lok Virsa, Department of Archaeology & Museum (DOAM), National Library of Pakistan (NLP), Pakistan Tourism Development Cooperation (PTDC) for consideration of the competent fora During 2020-21, the revised allocation for the development portfolio of Mass Media and CSTY sectors was Rs. 1,630.704 million against which an amount of Rs. 1200.000 million was released and utilized.

Major Activities

The Section carried out the appraisal and prepared working papers of about 06 CDWP and 30 DDWP level PC-Is/PC-IIs. The major projects included Pilot Project DTMB-A-Digitalization of Terrestrial Network of PTV (Chinese grant in Aid), Heritage & Urban Regeneration: Tourism Development in Lahore Fort and its Buffer Zone, Establishment of 100 KW MW Radio Station Gwadar (Revised), Up-gradation of Film Projection, Light and Sound System at PNCA Auditorium, Uplift of Lok-Virsa Premises into Professional, Gender Friendly Safe Space, Rehabilitation & Upgradation of Existing Facilities at Pakistan Sports Complex (PSC), Islamabad for preparation/Holding of South Asian Games, Establishment of Bio-Mechanical Lab at Pakistan Sports Complex (PSC), Islamabad and Facilitation of tourism in Islamabad – Market Promotion etc.

Other activities

Other activities performed by the Section during 2020-21 are given below:

- The Section worked on the various tasks assigned by the Prime Minister's Office including provision of material on two years' performance of the incumbent government.
- The Section processed and approved sports sector projects included in Sindh Development Plan under Prime Minister's Directive. The Section facilitated the sponsoring and executing agencies in implementation/execution and timely completion of



the projects initiated under the Prime Minister's directives. Detail of projects appraised is given in **Figure-1**.




Figure-1: Appraisal of Development Projects Through CDWP /

- The project titled Development Communication project which primarily aims at dissemination of key information and build awareness on national development processes, policies and



initiatives amongst target audiences at national and international level is being dealt with by the Section.

- Chief of the Section remained operational head of Manpower Section.
- The Section attended more than 100 pre-CDWPs, post–CDWPs, DDWPs, PSDP Review meetings, Standing Committees of National Assembly and Senate etc.
- Carried out the re-appropriation of development funds from slow to fast moving projects.
- The Chief regularly attended proceedings of a complaint filed by M/s X-dynamics before Federal Ombudsman against this Ministry for non-payment of outstanding amount on account of preparation of CPEC documentary. Moreover, in pursuance of direction of the Ombudsman, the case for clearance of pending dues was processed and got cleared through AGPR.
- The Chief has successfully dealt with a complaint filed by M/s Channel-7 Communications before Federal Ombudsman against this Ministry for non-payment of advertisement dues incurred on account of release of advertisements to print media.
- The Chief in pursuance of direction of Pakistan Information Commission has been designated/nominated as Public Information Officer of this Ministry. In this regard, the Section deals with requests of general public pertaining to different functions and mandate of the

Ministry.

10. MANPOWER SECTION

Section's overview

Manpower Section deals with all budgetary matters, policy guidelines, and technical appraisal of Skill Development schemes/programmes including Prime Minister's special Initiatives for Youth- *Kamyab Jawan*

Programme (KJP). The Section contributes towards producing highly skilled Youth; to achieve high level of excellence and to meet the requirements of international

competitiveness in line with 8th SDG's goal i.e. Decent Work and Economic Growth. In addition, the Section coordinates with provinces and donor agencies to support technical training

Box-1: Sectoral Overview

- Promoting employable skills as per latest market trends to achieve the ultimate objective of youth development. The Section coordinated with concerned implementing Departments / Ministries responsible for creating demand driven training system under the framework of National Skills Strategy.
- Accordingly, training is being imparted to youth in both conventional and Hi-tech/Hi-End trades through "Skill for All Programme "under Kamyab Jawan Programme (KJP). For promoting entrepreneurship culture, a comprehensive loan scheme namely "Youth Entrepreneurship Scheme (YES) is being implementing under KJP.

facilitate TVET Reforms and provide policy recommendations. The overview of the sector is given in **Box-1**.

Performance Review

Major accomplishments achieved during 2020-21 are as under:

- Online training to 500 assessors, out of which 355 institutes visited for assessment so far.
- Developed 100 qualifications while competency standards and assessment packages of 12 qualifications are in progress.
- 50 institutes identified for international accreditation while 09 of them reviewed by international agencies.



- Design and layout of Smart Tech labs for identified institutes in different trades has been finalized and tendering procedure initiated.
- Assessment and certification of approximately 20,000 trainees under RPL so far.
- Training of more than 42,000 youth in high tech/high-end trades/courses is in progress with online mode in response to COVID-19.
- Apprenticeship training of 1616 youth is in progress through 70 shortlisted enterprises.
- Training of 20,554 students from less developed areas has been resumed while another batch of 24,116 youth is started.
- Consultations with ILO and TEVTAs have been completed and 10 institutes identified for establishment of Centres for manpower export.
- Trades have been identified for training of 2500 TVET trainers.
- National Accreditation Council for TVET is established and functional.
- For TVET studies introduction in Madaris, 18 Madaris have been identified so far.
- Layout and design of Business Incubation Centres in under process for training TEVTAs employees.
- More than 11,000 loans are disbursed to the Youth till June 2021 of amount approximately Rs. 11 billion under Youth Entrepreneurship Scheme (YES).
- 15 percent of the loans disbursed so far belong to female youth for women empowerment.

Other Activities

The Section remained actively engaged in provision of technical support and conducive environment for implementation of training programmes all over the country. During 2020-21 almost 10 meetings for progress review of *Kamayab Jawan* Programme and PSDP funded projects were convened with concerned stakeholders from time to time. In addition, three online policy dialogues on youth employment, disability and gender were organized successfully.

Work in Progress

The Section is participating in handling of PSDP project titled "Social Sector Accelerator for Health, Nutrition, Education & Youth & Gender – National Priority Initiative" along with ongoing projects including Prime Minister's initiative of *"Kamyab Jawan* Programme to empower the youth.



11. GOVERNANCE SECTION

Section's Overview

The Governance Section is responsible to formulate and process development plans, policies, programmes and projects pertaining to knowledge management, organizational restructuring, institutional reforms, judicial reforms and capacity development of institutions for effective service delivery. Key initiatives of governance framework envisage socioeconomic development of less developed regions, provision of equal opportunities, fairness, justice and strengthening institutions while adhering to democratic principles and rule of law in the society (**Box-1**). With a comprehensive reform agenda, the governance indicators are expected to improve in upcoming years.

The development activities/ programmes / projects of the Governance Sector revolve around tax reforms, public financial management reforms, process re-engineering,

organizational restructuring, judicial reforms and institutional capacity development for effective service delivery.


Box-1: Good Governance

Good Governance is critical to the successful achievement of outcomes of public policies, programmes and targets which are prerequisite for economic growth and development. As growth generates income, good governance trickles this effect down to the masses, particularly the vulnerable segment of the society.

Performance Review

The government has undertaken number of initiatives to improve governance indicators and making government open, transparent, accountable, and responsive to citizens. An amount of Rs. 4.8 billion was allocated for the governance sector in 2020-21 against which an amount of Rs. 7.25 billion has been utilized. The portfolio of Governance comprised of 42 development schemes costing of amounting more than Rs. 150 billion.

During the year, 31 projects, programmes, and concept clearance proposals were processed/presented in DDWP, CDWP/CCC and ECNEC. Details reflected in **Figure-1**.



Industries & Commerce Section deals with development related activities and policies of four Federal Ministries/Divisions and their administratively controlled departments/organizations, which are Ministry of Industries & Production (MoIP); Ministry of Commerce

including Textile Wing; Mineral Wing of Petroleum Division; and Board of Investment. Anv development project of above-mentioned entities, whether it is of DDWP, CDWP, or DWP level is examined and processed by this Section as per the guidelines and standards of the Planning Commission. This Section provides necessary input regarding relevant policies like trade policy, domestic commerce policy, SMEs policy, textile policy, etc. Sectoral overview is given in Box-1.

Box-1: Sectoral Overview

- Robust and vibrant production, commerce and mineral sectors are the backbone of an economy. These sectors help countries in achieving development, prosperity, employment, and wealth creation.
- Like all sectors of the economy, production and commerce sectors were hit severely by COVID-19 pandemic. Due to timely intervention of GoP, the sector not only coped with the challenges of pandemic, but fulfilled the demand in international markets. Resultantly, a robust growth was postulated by the sector showing elevated growth of LSM 9.29 percent, and S&M 8.3 percent. Similarly exports went upto the level of US\$ 25.3 billion.

Performance Review

In line with the functions of the Section already assigned by Ministry, during 2020-21 the Section examined and processed new as well as revised development projects of Ministry of Industries & Production (MoIP); Ministry of Commerce including Textile Wing; and Mineral Wing of Petroleum Division. These projects fell in various levels of approval forums like DDWP and CDWP. During 2020-21, the sector was



provided Rs. 1775.791 million, against which Rs. 1391.472 million were incurred, giving an overall utilization of 78.36 percent.

Major Activities

The Section performed the following major activities during 2020-21:

Policy Initiatives

Policy consistency is critical for public and private sector to develop their investment plans. Section provided inputs and support to line ministries in launching the following policies regarding Electric Vehicle Policy, 2020, Textile and Apparel Policy, 2020-25, National SME Policy, 2020 and National Domestic Commerce Policy, 2020-25.

PM Directives/Tasks Assigned

Support was provided in setting up "Balochistan Mineral Exploration Company (BMEC)" as joint venture between Govt. of Balochistan and Federal Govt. having shareholding of 90 percent and 10 percent respectively.

Appraisal of projects

The Section processed following projects during 2020-21 through different approval forums like DDWP and CDWP as per details in **Table-1.**

- Examined and analyzed forty-seven Summaries for ECC of Cabinet and prepared briefs/ talking points for Minister/ Secretary/ Member (PSD&C).

13. ENERGY INFORMATION SYSTEMS & COMPUTER/INFORMATION AND COMMUNICATION TECHNOLOGY SECTION

Section's Overview

The Energy Information Systems & Computer/Information & Communication Technology (EIS&C/ICT) Section technically appraises PC-Is and PC-IIs of ICT Sector related schemes submitted by the Sponsoring Ministries for consideration/approval of the CDWP and

ECNEC. For this purpose, working papers/Summaries for Pre-CDWP/ CDWP/ECNEC meetings are to be prepared. In addition to this, the ICT Section prepares technical comments for ICT component of the projects sent by other Sections of Planning Commission for inclusion in working papers CDWP; for processes projects for Concept Clearance and Cash/Work Plans submitted by Ministries/Agencies.

Automation System (iPAS) **(Box-2).** During the year, PSDP module was implemented fully and focal persons of Federal Ministries and departments were given training in its operations. The PSDP 2021-22 book was generated through the automated system in parallel to existing semi-automated method. PC-Is/ PC-IIs module has been developed and under trial tests before it can be rolled out in 2021-22. The iPAS system is planned to be fully implemented by the end of December, 2022.



Section's Overview

The Section appraises and evaluates development projects PC-Is and PC-IIs, programmes, and policy interventions related to S&T and Higher Education Sectors. S&T Section is in close proximity with main stakeholders of these sectors such as Higher Education Commission (HEC), Universities, Ministry of Science & Technology (M/o S&T) and Scientific Research Organizations.

However, objective of the sector, programmes and projects are not restricted to single ministry instead, projects from other R&D organizations like Pakistan Atomic Commission (PAEC), Energy NESCOM, SUPARCO, Pakistan Meteorological Department (PMD), Division (Survey Defense of of IPC and Pakistan), Ministry Pakistan Nuclear Regulatory Authority (PNRA) are approved and

Performance Review

The major focus of the Section remained on the development projects/schemes envisaged to meet the major targets set-up in 2020-21 for Higher Education and Science & Technology Sectors by prioritizing and processing development projects

In line with the assigned functions of the Section as envisioned in the Ministry's mandate, the Section during 2020-21, examined and processed new as well as revised development projects received from the sponsors. These projects fell in various levels of approval competencies such as DDWP, CDWP and ECNEC.

During 2020-21, the Higher Education Sector was provided Rs. 28,060.000 million under the federal programme which was almost fully utilized with collaborative efforts Whereas, S&T Sector was allocated Rs. 4458.070 million. However only Rs. 1563.095 million (35 percent) were utilized due to some inherent issues with certain projects. Efforts were made to resolve these issues with sponsors.

Major Activities

The Section performed the following major activities during 2020-21:

PM Directives / Tasks Assigned

During 2020-21, the Section continued to work on the projects prioritized by the Prime Minsters' Task Force on Knowledge Economy (PMTFKE). In this backdrop, Rs. 3060.893 million were allocated for the seven projects of PMTFKE for S&T Sector. Further, two ECNEC projects worth Rs. 36912.000 million of the PMTFKE for S&T Sector were appraised and processed by the Section and subsequently approved at the relevant fora in the year 2020-21. In addition, inputs /viewpoints were given to the nine DDWP projects of the PMTFKE for S&T Sector approved during the preceding year presented in the DDWP of MoST.

approved by the ECNEC. The former scheme will be funded from PSDP while the later will be funded on 50 percent cost sharing basis between federal PSDP and provincial ADP.




15. WATER RESOURCES SECTION

Section's Overview

Water Resources Section appraises and evaluates development projects PC-Is and PC-IIs of the Water Resources Development and Management and advises & facilitates the relevant line ministries/departments to overcome the water scarcity issue of Pakistan with respect to Climate Change, improve the environment/water pollution, flood mitigation, increase the cropping intensity and agriculture production to meet the needs of growing population. PC-I and PC-IIs of large/medium/small dams, canals, drainage, improvement of existing irrigation system and flood mitigation are being appraised/ evaluated by this Section. In addition to the evaluation process, formulation of Water Sector's Annual Development Plan, Implementation Framework of National Water Policy, briefs for National Assembly and Senate Standing Committee, implementation of President/P.M Directives were worked during 2020-21. Water Sector's future strategies are based on the welfare, poverty alleviation and wellbeing of people. In addition, the Section performs following major functions:

- Formulation of strategies for implementing development programme in line with the policies of the Government for accomplishment of maximization of agricultural productivity.
- Preparation, processing and evaluation of annual, medium and long-term development plans and perspective plan in the water sector.
- Technical and economic scrutiny of development projects/programmes relating to water resources and preparation of working papers/summaries for CDWP/ECNEC & ECC. Details of appraisal of development projects is reflected in **Figure-1**.

- Regular review meetings with all executing agencies (WAPDA, Provinces and others) to discuss and resolve the bottlenecks/issues of on-going and new development projects.
- Offering comments on summaries moved by ministries/divisions to Prime Minister's Office.
- Submitting Sectoral Feedback for Economic Survey of Pakistan, Finance Minister Budget Speech and Pakistan Bureau of Statistics.
- Submitting implementation status of Senate/National Assembly (Standing Committee's decisions).
- Technical appraisal/comments on field & desk monitoring for assessing smooth financial and physical progress of water sector's projects included in PSDP 2020-21.
- Three meetings of Scrutinizing Committee for Emergent nature flood schemes were attended.
- Formulation of strategies for implementing development programme in line with the policies of the Government for accomplishment of maximization of agricultural productivity.

- Advised and assisted Federal, Provincial Governments and other bodies in all matters pertaining to the development of water resources (Box-1).
- A number of Court cases were attended and reports were submitted to Honorable Supreme Courts of Pakistan, Balochistan High Court and Supreme Appellate Court of GB.

- Accordingly, a number of new projects were included in PSDP 2020-21 to achieve the targets set for water sectors. Special focus was on the improvement of connectivity in less developed districts and other areas of Pakistan for which different development packages/plans were formulated for Southern Balochistan, Gilgit Baltistan and Karachi.
- Participated in field visits along with Monitoring Teams and inquiry Committee's meetings.
- Participated in working group on Water Resources for revision of Pakistan's Intended National Determined Contribution (INDC) on Climate change and to achieving Stabilization of GHG in atmosphere, targets Set in Paris agreement.

Work in Progress

- Work on formulation of implementation framework and consultations for Implementation Framework of National Water Policy 2018 with all stakeholders is under process.
- Facilitation to resolve the Boundary Dispute between KP and G.B Governments for smooth implementation on Diamer Basha Dam.
- Monitoring, evaluation and quarterly review Task of Diamer Basha Dam (Dam Part) and Mohmand dam Hydropower mega projects for timely completion is underway.
- Technical and professional input/evaluation of TORs for Hiring of General Consultant for Diamer Basha Dam Project and other Water Sector's Development Projects.

- During 2020-21, about 17 new projects (small recharge/check dams) costing Rs. 51,000 million under Southern Balochistan Package were technically appraised by the Water Resources Section. In coming years technically and professional assistance to resolve the bottlenecks/issues will be provided to Balochistan through regular consultative/review meetings.
- Revival of RBOD-II & Nai Gaj Dam Project costing Rs. 61.00 billion & Rs. 45,081 billion respectively through consultation with all stakeholders (GoS, MoWR, WAPDA).
- Storm Water Drains Projects includes revamping projects of Nullahs and Rivers in Karachi under the Karachi Transformation Plan. Under this umbrella Plan, following four water sector projects were processed and these will be reviewed and monitored by the Section for implementation on fast-track basis to cater the rain water harvesting/urban flooding:
 - Restoration & Revamping of Mehmoodabad Nullah and its Tributaries with cost of Rs. 8657.43 million.
 - Restoration & Revamping of Gujjar Nullah at Rs. 9570.93 million.
 - Restoration & Revamping of Orangi Nullah with total Cost amounting to Rs. 8671.67 million.
 - Restoration & Revamping of Liyari & Malir Rivers with Associated Tributaries at cost of Rs. 7605.708 million.

16. ENERGY WING

Wing's Overview

The Energy Wing is entrusted with the role of appraisal, processing and approval of Energy Sector Projects (Power, Fuel, Energy Finance and Economics Sections), Formulation of PSDP of Energy Sector Projects, preparation and review of short term/ long term energy plans and furnish comments on energy policies. The Energy Wing appraises and evaluates development projects PC-Is and PC-IIs of the Energy Sector including energy efficiency, renewable energy, thermal, Nuclear, Hydro Power and Oil & Gas sector received from line ministries/ departments. as per the guidelines and standards of the Planning Commission and furnish comments

Box-1: Sectoral Overview

- Approximately 1145 MW generation capacity was added in 2020-21, by commissioning of K-2 Nuclear Power Plant. 8,191 MW will be added to the generation mix during 2021-22 including 960 MW from renewable energy. Energy mix for power generation will gradually move towards domestic coal, renewable and hydropower resources in the upcoming years, as the least cost and sustainable option.
- The NTDC transmission system has been strengthened by addition of 1,050 MVA on 500 kV and 250 MVA on 220kV level for evacuation of additional power to the National Grid during 2020-21. The existing transmission lines have been extended by 730 km on 500 kV and 260 km on 220kV level during the period. In 2021-22, the transmission capacity is planned to be enhanced by 2,250, 2,750 and 4,000 MVA on 500kV, 220kV and ±660 kV network and about 718, 760 and 886 km transmission lines will be constructed on 500 kV, 220 kV and ±660 kV respectively.
- The physical progress of the power sector projects falling under Public Sector Development Programme as well as in private sector suffered badly by the pandemic, therefore, the utilization of PSDP funds remained on a lower side.





Physical Planning & Housing Section is mainly responsible for formulation of national policies, plans, and facilitate provincial/regional governments for managing urbanization including planning/

programming of programmes/ projects pertaining to water supply, sanitation, urban development, urban renewal, slum upgradation, housing etc. The Section's provides technical support and share emerging knowledge for resolving urban and regional development issues to achieve SDGs-6 and 11 nation targets. The Section's undertakes technical appraisal of

Box-1: Sectoral Overview

The urbanization process in the country is characterized by four features. Firstly, the urban areas have become the major contributors to the national economy, generating and diffusing growth across the country. Secondly, the pattern of urbanization across provinces exhibits large variation. Thirdly, there has been over concentration of urban population in fewer urban areas. The fourth important feature is an expanding middle class comprising of youthful and skilled labor force.

The ongoing and new projects were included in PSDP 2020-21 to achieve the sectoral targets. Special focus was given to pursue targets set in respect of SDG-6 and SDG-11.

development schemes submitted by various government agencies for consideration of the competent approving forums i.e. DDWP, CDWP and the ECNEC. The overview of the sector is given in **Box-1**.

Performance Review

During 2020-21, the Section examined and processed new as well as revised development projects of M/o PD&SI (SIDCL), Ministries of Communications (NH&MP), Interior, Aviation, Housing & Works, Maritime, Defense, M/o KA&GB and provincial sectoral projects. These projects fell in various levels of approval competencies such as DWP, DDWP, CDWP and ECNEC.

During 2020-21, an amount of Rs. 26 billion was allocated in PSDP for PP&H sector out of which an amount of Rs. 20 billion was incurred, giving an overall utilization of 77 percent. Similarly, the provincial governments allocated substantial amount for the execution of projects relating to the sector, i.e., Punjab Rs. 37.9 billion, Sindh Rs. 11.39 billion, Khyber Pakhtunkhwa Rs. 17.84 billion, Balochistan Rs. 6.211 billion and Azad Jammu and Kashmir Rs. 6.412 billion.

Major Activities

The Section carried-out technical appraisal of projects pertaining to development of water supply, sanitation and urban infrastructure; government offices & residential accommodation; schools. universities; hospitals; capacity building of municipal governments, etc. The Section carried-out technical appraisal of development projects of SDGs programme. The Section provided technical assistance to various ministries/ departments pertaining to preparation of programme/project documents. The Section prepared sectoral chapters for inclusion in Annual Plan and PSDP 2020-21.



18. TRANSPORT AND COMMUNICATION SECTION

Section's Overview

The Section appraises and evaluates development projects PC-Is and PC-IIs of the transport infrastructure sector and advises & facilitates the

relevant line ministries / departments for provision of safe, reliable, robust and efficient transport system. PC-I and PC-IIs of each subsector of the transport including Roads & Bridges, Railways, Ports and Shipping & Aviation are appraised / evaluated by this Section as per the guidelines and standards of the Planning Commission. In addition, work on formulation of master plan for each sub sector was carried out

Box-1: Sectoral Overview

- Effective and efficient transport & logistic sector is backbone of an economy. It links economic and urban clusters with domestic & international markets to enhance broader economic performance. The Section remained engaged to meet the major targets set-up in National Transport Policy, 2018.
- Accordingly, the ongoing and new projects were included in PSDP 2019-20 and PSDP 2020-21 to achieve the targets set for roads & railways sectors. Special focus was on the improvement of connectivity in less developed districts and other areas of Pakistan for which different development packages/plans were formulated for South Balochistan, Gilgit Baltistan and Karachi.

Performance Review

The Section examined and processed new as well as revised development projects of M/o PD&SI (SIDCL), Ministries of Communications (NHA, NTRC, NH&MP), Interior (CDA), Railways (Pakistan Railway), Aviation (CAA, ASF), Housing & Works (Pak. PWD), Maritime (GPA, PQA, KPT), Defense (PMSA), Defense Production (KS&EW), M/o KA&GB (Gilgit Baltistan and AJ&K) and provincial transportation projects. These projects fell in various levels of approval competencies such as DWP, DDWP, CDWP and ECNEC.

During 2020-21, an amount of Rs. 173.8 billion was allocated for various projects of T&C under the federal programme. Against this, an expenditure of Rs. 127.625 billion was incurred by the end of the year, giving an overall utilization of 73.4 percent.

Availability of financing for the infrastructure projects has been a recurring problem, as huge capital costs are involved in case of most of the T&C sector projects. While the normal PSDP allocations have been increased considerably during the last couple of years, the available resources cannot meet the growth of demand of the T&C Sector projects. Therefore, a number of projects were apprised and initiated with financing primarily on PPP /BOT. In case of projects having a gap for the commercial viability, provision of Viability Gap Funding (VGF) was ensured.

Major Activities

The Section performed the following major activities during 2020-21:

Implementation of National Transport Policy (NTP) 2018

The Section finalized the NTP in consultation with all concerned stakeholders during 2018-19 which was approved by the Cabinet in May 2018. The Section continued work on the implementation of the NTP 2018 to implement the National Transport Master Plan. The final draft of the Master Plan is being reviewed.

PM Directives/Tasks Assigned

During 2020-21, the Section continued to worked on the various tasks assigned by the Prime Minister's Office. In light of directives after 100 days' performance of the Cabinet meeting, several projects in Roads and Railways sector are being approved for carrying out commercial feasibilities of the projects for implementation through PPP mode. This will help in reducing the burden on the Federal Budget. This Section facilitated in evaluating the PC-IIs of schemes of Pakistan Railways and NHA during the year 2020-21. The Section worked in formulating the Development packages for Karachi, Southern Balochistan and Gilgit Baltistan.

COVID-19 challenges

The transport & logistics sector was hit badly due to the COVID-19 pandemic. The construction industry drawing most of its work from the roads, railways, airports and port construction was severely affected. The passenger and freight transport in road, railways, aviation and through ports was decreased at an alarming rate due to lock downs. The Section suggested various measures to overcome the issues faced by the transport and construction industries.






Figure 1: Appraisal of Development Projects Through CDWP/ ECNEC During 2019-20 and 2020-21 – A Comparison

19. PROJECTS' WING

Wing's Overview

The Projects Wing deals with Monitoring & Evaluation of PSDP financed Projects. Under this Wing, the Project titled "The Strengthening of M/O PD&SI in Monitoring & Evaluation of PSDP financed projects" has been proving a yardstick to measure that whether the total PSDP financed projects are on track with regard to schedule, budget line and scope against the plans. The Project Wing Monitors and Evaluate the PSDP finance projects of Infra Sector, Social Sector and Other Sectors. A dedicated team has been housed in Balochistan Camp office, Quetta for exclusive monitoring of far flung projects being executed in Balochistan Province including Balochistan special package.

PSDP is the main instrument or driving force to channelize Government funds for socio-economic uplift of the country. PSDP has been instrumental in raising infrastructure, connectivity and social sector development. The PSDP is aligned with the objectives of development of less developed region and targeting pro-poor growth by increasing employment and leveraging opportunities in rural and urban areas.

Evaluation Section of Projects Wing has been conducting the evaluation of completed PSDP financed projects after submission of PC-IV's. To make monitoring more effective and to facilitate the working of Projects Wing, MIS Section the Wing has been managing a web-based Project Monitoring and Evaluation System (PMES).

The Coordination Section of the Wing has been performing as a hub for Planning and implementation & reporting of all Projects Wing's activities for more coordinated efforts and decisions making in coordination with and internal external actors in attaining the collective objectives (Box-1).

Performance Review

Planning Commission

Box-1: Overview

- The Projects Wing has been delivering the monitoring & evaluation of all PSDP financed projects across the Pakistan in coordination with Sponsoring Ministries and Provinces including AJ&K & GB.
- During 2020-21, total 525 projects were monitored surpassing the combined number of projects monitored during the last 5 years.
- Significant saving in time and cost has been affected due to effective monitoring.
- Reforms in M&E system have been framed.
- Besides, total 26 completed projects have been evaluated during 2020-21.
- Projects Wing has promoted the web-based data management through PMES of all the projects by building capacity of all the Sponsoring Ministries.

maintains an oversight on the implementation of development projects, baseline to be implemented by the sponsoring Ministries/Divisions. Planning Commission through Projects Wing has adopted the Result Based Monitoring (RBM) of development project. During 2020-21, Projects Wing has monitored a total of 525 No. of projects and evaluated 26 projects. Based on the RBM parameters, some of the major observations were taken-up with the executing agencies and proposed corrective measures to improve the implementation of the development projects.

Major Activities

The Ministry is strengthening its Monitoring & Evaluation for enhancing effective implementation of projects. The Key issues highlighted during monitoring in 2020-21 are given in **Table-1**.

Monitoring exercise indicated that the implementation of projects had suffered mainly due to lack of capacity in planning and management of projects before execution. Meagre allocation of resources to monitor a large portfolio results into delays and cost over runs in majority of projects, improper preparation/designing of the PC-I document leading to delays, cost over runs, change in scope of work and ultimate revision of the PC-Is.

Evaluation of completed PSDP financed Projects Projects Wing undertakes evaluation of the development projects. lt includes the systematic and objective assessment of an on-going completed or project, programme or policy, its design, implementation and results. The aim is to determine the

development efficiency, effectiveness, impact and sustainability against RBM matrix planned in PC-I. Total twenty-six projects (26) were evaluated during 2020-21. The recommendations made in the evaluation reports were beneficial to the stakeholders, as it provided guidelines for improvement in policy & plans formulation and future development direction.

- Development of Dashboard is in process.





Amendment in Rules of Business pertaining to M/o PD&SI

Admin Wing undertook a comprehensive exercise of updating of Rules of Business, 1973 pertaining to this Ministry in a bid to provide a legal framework for the work being done by the Ministry but not reflected in the Rules. After excessive deliberations and consultations with all stakeholders, a draft was prepared which was forwarded to Cabinet Division for amendments in the said Rules in respect of this Ministry. - Steering Committee on ICT initiatives has given recommendations on the formulation of IT policy.
- Several meetings were conducted under the chairmanship of Minister for PD&SI and Special Assistant to the Prime Minister on CDA to address the water issues of Islamabad and Rawalpindi.
- The Public Private Partnership Authority (P3A) was established under the Public Private Partnership Authority Act 2017 (VIII of 2017). In order to allow P3A to undertake projects through a streamlined and efficient approval and appraisal process, certain amendments to the Act were proposed and the Ordinance was promulgated in July 2020 to attract investors for Public Private Partnership Projects to be executed through the P3A. The Ordinance was extended for a second term on 4th November, 2020.
- The changes proposed through the Ordinance and some additional changes deemed necessary by the Parliament were incorporated in the Public Private Partnership (Amendment) Act, 2021 which received assent of the President on 24th June, 2021.



Consequent to the Act the process for restructuring of the organization, including its BOD, was started to make it more functional.

- Sindh Infrastructure Development Company (SIDCL) was transferred from Cabinet Division to the M/o PD&SI in 2020. Technical Supplementary Grant (TSG) amounting to Rs. 16,628,933,000/- was obtained for the 23 schemes of SIDCL.
- SIDCL is entrusted with executing important infrastructure projects in Sindh, including roads, water filtration plants and most importantly the Green Line BRTS in Karachi. Timely disbursement of funds was ensured by M/o PD&SI for execution of these projects. Thirteen projects were transferred to M/o Housing and Works due to relevance of scope.
- National Disaster Risk Management Fund (NDRMF) was transferred from M/o Climate Change to M/o PD&SI in 2021. NDRMF works for reducing the socio-economic and fiscal vulnerability of the country & its population to natural hazards and climate change, through financing investments in disaster risk reduction and preparedness.
- NDRMF has been on the fore front of the Government's efforts to fight the COVID-19 pandemic. Under the Pakistan National Emergency and Response for COVID-19 NDMA (ADB) programme Rs. 7,899,000,000/- were disbursed for various initiatives in response of the threat caused by COVID-19.

1. NATIONAL LOGISTICS CELL

Cell's Overview

Notwithstanding the negative fallout of COVID-19 pandemic on business activities, National Logistics Cell (NLC) – the multimodal end to end logistics solutions provider – performed quite well during 2020-21. NLC actively pursued organizational transformation plan with focus on fleet upgradation in line with National Freight & Logistics Policy, automation of systems, digitalization of processes, talent hunt and incentivization of best performances. Special attention is being paid to enhance brand visibility of the organization in Pakistan through various means of conventional and digital media. Following is the brief overview of various set ups of NLC during 2020-21:

Logistics Services

Logistics Services comprise Road Freight, Dry Ports, Marine & Air Services, NLC Express Freight Train (NEFT) and Polymers. Logistics Services has been successful in attaining substantial improvement in various operational aspects. To improve efficiency, the organization aggressively pursued fleet upgradation plan inducting most modern prime movers to its fleet. These measures significantly improved the capacity of NLC as amply demonstrated in haulage of huge volumes of cargo during 2020-21. Logistics Services successfully transported 1.1 Million Metric Ton imported wheat from ports at Karachi to different destinations across the country for Punjab Food Department and Pakistan Agricultural Storage & Services Corporation (PASSCO). In addition, 0.4 Mn M Tons local wheat was transported for Gilgit-Baltistan government & Punjab Food Department. Liquid cargo fleet is actively involved in transportation of white and crude oil in strict compliance with Oil and Gas Regularity Authority (OGRA) rules ensuring best Health, Safety and Environment (HSE) standards. Part of Liquid Cargo Fleet is involved in transportation of edible oil from Karachi Port to different oil mills across the country. Logistics Services undertakes transportation of fertilizer and coal for major clients.



Pakistan Ordnance Factories' transportation contract of stores and ammunition is being undertaken by Logistics Services.

Marine & Air Services

Considering the market potential, available opportunities and above all the need for extending end-to-end multimodal logistics services, NLC launched Marine & Air Services in October 2019 adding other segments of supply chain. In a short span of time, the newly established set up became operational in line with the business demands.

Dry Ports

NLC operates dry ports at Sost (near Khunjerab on KKH), Thokar Niaz Baig Lahore, Multimodal Transit Hub Jia Bagga Lahore, Quetta, Karachi and Hyderabad. These dry ports are adequately equipped with latest infrastructure and machinery to handle all kinds of cargo. Clearance facilities are being provided to businessmen closer to the business hubs.

NLC Express Freight Train (NEFT)

The Locomotives of NLC under wet lease agreement with Pakistan Railways have completed 3075 trips and travelled more than 6.00 million kilometres on Pakistan Railway network since 2015. NEFT has contributed over Rs. 8 billion revenue for Railways in last 6 years. NEFT is exploring business opportunities with Pakistan Railways in context of CPEC especially in fields of track access and hiring of full block trains etc.

NLC Polymers

Known for quality rubber and plastic parts manufacturing, NLC polymers has diversified its product range at competitive rates for Government and private sector clients. Besides manufacturing a number of other customized and standard parts, NLC Polymers re-rubberized APC Road Wheels, SP Gun Road Wheels and SP Gun Track Pads for various Army Workshops and Heavy Industries Taxila etc.



NLC Engineers

Established in 1978, NLC Engineers, has achieved great all-round success in execution of mega projects thus becoming a major contributor in nation building efforts. NLC Engineers employ its best professional as well as experienced workforce with latest machinery for timely completion of diverse projects. NLC Engineers have completed scores of projects including construction of roads, flyovers/ underpasses, educational institutes, hospitals, bridges, sports facilities, border terminals, rehabilitation works in disaster hit areas and projects in remote and inaccessible areas of Pakistan. Following are some of the mega projects completed by NLC Engineers during 2020-21 (**Table-1**).

HQ Border Terminals

NLC operates border terminals at Wagha, Torkham/ Jamrud, Chaman, Ghulam Khan Kalay, Kharlachi and Taftan. NLC is planning to set up new border terminals at Angoor Adda and Badini at Pakistan – Afghanistan border whereas Gabd and Mand at Pakistan - Iran border for promotion of regional trade. As terminal operator, NLC is providing requisite administrative and technical facilities to other government agencies like Pakistan Customs, Immigration, Federal Investigation Agency (FIA), National Database and Registration Authority (NADRA) and Anti-Narcotics Force (ANF) to perform their respective effectively responsibilities under challenging security and administrative environment at far flung / remote areas. Government's efficient trade and economic policies have resulted in increased trade volumes with neighbouring countries. NLC is putting concerted efforts to upgrade existing terminals to reduce dwell time, ensure transparency and enhance ease of doing business. Brief performance appraisal of Border Terminals in 2020-21 is in Table-3.

Applied Technologies Institutes (ATIN)

ATINs are leading technical and vocational training providers that work as CSR project of NLC. Free vocational training is being provided to underprivileged students with assistance of national and international organizations. So far 62000 students have been trained at these institutes. Despite closure of institutes for about four months due to COVID-19, ATINs trained 2,538 students in ATINs located at Mandra, Dina, Amangarh, Khairpur and Gilgit in 2020-21. The training is diversified in different trades. ATINs at Mandra, Dina and Gilgit are in the process of getting international accreditation through NAVTTC. NLC has approached National Highway and Motorway Police for provision of license to HTV/ LTV trainees at ATIN Dina. Recognition of Prior Learning (RPL) Test is being conducted at ATINs for issuance of authentic certification to already skilled manpower in collaboration with NAVTTC. More than 6,000 skilled individuals have been tested and certified so far. ATIN Mandra, Dina, Amangarh and GB have been nominated for establishment of Hi-Tech Skills Centres under PM's Kamyab Jawan Programme.



NLC Tolling

NLC started tolling operations in 1999. Presently 33 toll plazas from Kohat in the North (KP) and Hub in the South (Sindh) are being managed and operated by NLC. Through efficient toll collection, NLC has contributed an amount of Rs. 100.82 billion to national exchequer till June 2021. It is providing job opportunities to over fifteen hundred individuals, both civilian and retired army personnel. NLC Tolling actively participated in Billion Tree Tsunami, Anti-Narcotic, Anti-Corruption and tax awareness campaigns during 2020-21.

NLC has come as an efficient, reliable, most modern and compatible logistics providing end-to-end multimodal services around the globe. It's a huge capability at national level to handle crises and exigencies situations. NLC, with its modernised fleet is looking towards the regional trade as a matter of national contribution.



2. PAKISTAN BUREAU OF STATISTICS

Bureau's Overview

Pakistan Bureau of Statistics (PBS) is attached Department of the Ministry, responsible for collection, compilation and dissemination of reliable and timely statistical information to the policy makers, planners and researchers. It publishes a variety of reports, based on primary and secondary data, especially on economics and social aspects of the country.

PBS formulates principles for collection, compilation and dissemination of official statistics in Pakistan. It provides standard concepts, definitions and classifications pertaining to official statistics. It executes all national censuses and surveys and cooperates with international bodies and committees in all statistical matters

Performance Review

The PBS performed all its routine activities in addition to some new initiatives under the "Digital Pakistan" vision of the Prime Minister of Pakistan as per details given below:

Major Activities

The Section performed the following major activities during 2020-21:

Primary Sources

Population & Housing Census is being conducted after every 10 years. Six censuses have been conducted since 1951. Latest one is Population and Housing Census, 2017. The Council of Common Interests (CCI) has approved the final results of Census-2017 in its meeting held on 12.04.2021 and directed that the process of next census should start as early as possible according to International best practices by using latest technology. Accordingly, PBS has started preparatory work to conduct 7th Population and Housing census in the country. As per direction

of M/o PD&SI a committee has been constituted for recommendations & adoption of best practices for upcoming Population Census and six meetings of the committee have been held so far. PBS has prepared the budget estimates for 7th Population & Housing Census amounting to Rs. 23 billion and an allocation of Rs. 5 billion has been made in 2021-22 budget.

- Mouza Census is being conducted after every 5 years and 8 series available since 1971. Latest one is 2020. Key Findings Report of Mouza Census 2020 has been issued.
- **Census of Manufacturing Industries (CMI)** is being conducted after 5 years and 7 series are available since 1970. Latest one was conducted during 2015-16.
- Economic Census, a proposal/Roadmap is under submission for integration of Economic Census and 7th Population & Housing Census.
- PSLM (District level Survey) provides information on social indicators (Education, Health, Housing, Water& Sanitation& ICT, Disability & Migration Statistics) and is main source for estimation of Multi-dimensional poverty Index (MPI) & SDGs (21). PSLM is being conducted every alternate year and 6 series are available and latest one is 2019-20.
- Household Integrated Economic Survey (HIES) (Provincial level Survey): Provides information on social indicators (Education, Health, Housing, Water& Sanitation& ICT) along with economic indicators. It measures income & consumption patterns and is main source for monitoring of SDGs (24) and Consumption Based Poverty. HIES is being conducted every alternate year and 6 series are available and latest one is 2018-19.
- Labour Force Survey (Provincial Level) is being conducted every year and 35 series are available since 1963 and latest one is 2018-19. It provides information on Civilian Labour force, unemployment, employment by industry & Occupations, migration and informal & Formal employment. 10 SDGs are monitored through LFS.

- Labour Force Survey (District level Survey was first time conducted during 2020-21 and 7200 blocks covered and report will available by end of 2021.
- Pakistan Demographic Survey (PDS) is being conducted to provide data for Births and Death for estimating intercensal growth rate since 1984 and 19 series are available and latest one is conducted with reference period of 2020 and filed work will be completed by July 2021.
- Price Statistics: PBS is responsible for collection, compilation and dissemination of retail/wholesale prices as well as computation of price indices. PBS has been preparing and releasing Consumer Price Index (CPI), Sensitive Price Indicator (SPI) and Wholesale Price Index (WPI) for planners and policy makers of public and private sectors since its establishment in 1950. Rural Price Index (RPI) is being compiled by PBS since 2015-16 on the basis of prices collected from 27 rural centres.

Secondary Sources

- Compilation of National Accounts: Yearly National Accounts of Pakistan are being compiled since 1960. Rebasing of National Accounts from 2005-06 to 2015-16 is being carried out and survey results were reviewed by the Technical Committee. In order to compile quarterly National Accounts, a technical committee has been constituted. Proposal for compilation of provincial/regional National Accounts is under consideration.
- **Social Statistics**: Social Statistics are being compiled on yearly basis by taking secondary data from all provinces & organizations and compendium on Gender & Environment every 4th year.
- **Trade Statistics**: Since its inception, PBS has been giving utmost importance to Trade Statistics. Trade Statistics Section of PBS is responsible for compilation and dissemination of trade figures as well as computation of trade indices. Indices of External Trade statistics of Pakistan are being compiled on monthly basis.



Initiatives under "Digital Pakistan" Vision of the Prime Minister of Pakistan

- **Digital Transformation**: PBS has undergone "Digital Transformation" and not only shifted from manual approach to electronic data collection for all its activities with built-in monitoring systems linked with GIS for reliable, timely and credible data, but have paradigm shift on data dissemination from unidimensional mode of fixed formats into interactive customized dashboards: which provides open access to data with infographics along with comparison with previous years of several indicators as per requirement of users.
- Installation of dissemination Kiosks: PBS for increasing statistical literacy among data users and to create awareness about importance of data for informed decision making has installed their dashboards and information management system at first phase in dissemination Kiosks at PBS headquarters and Ministry of Planning Development & Special initiatives (being the central ministry where all projects get approved). This will enable Policy Planners to have instant and updated information on data through customized dashboards for decision regarding development programmes. In second stage theses kiosk will be installed in provincial Planning & Development offices for informed and timely decision making by the provinces.
- Electronic Data Collection with Monitoring Dashboards: PBS has shifted to tablet based electronic data collection system and data relating to i) Price Statistics, ii) PSLM, iii) LFS and iv) PDS is being collected using tablets. Automated Survey Management System (ERP Solution) is being used.
- **Decision Support System**: PBS has developed Decision Support System for Inflation (DSSI) and preparing Evidence Based Decision System for Planning Commission/Provincial P&Ds.
- E-Governance/Process Automation: PBS is working on Human Resource Management System and Budget Management System, LMIS.



- Support Services Provided to other Departments: PBS being National Statistical Organization (NSO) and Custodian of sampling frame provide the following services to National/ International organizations under General Statistics (Reorganization) Act – 2011:
 - Sample Designing including estimation of sample size.
 - Provision of maps of selected blocks.
 - Physical identification of block boundaries.
 - Assistance in training if needed.
 - Field data collection (subject to availability of PBS staff).
 - Preparation data collection software.
 - Preparation of Tabulations/Descriptive reports.

3. PAKISTAN ENVIRONMENTAL PLANNING AND ARCHITECTURAL CONSULTANTS

PEPAC's Overview

Pakistan Environmental Planning and Architectural Consultant Limited (PEPAC) was established incorporated in 1974 to provide town planning and architectural consultancy services for projects initiated by the Government, Semi Government and autonomous bodies. It is registered with Securities Exchange Commission of Pakistan (SECP), Pakistan Engineering Council and Pakistan Council of Architects and Town Planners and is administered by a Board comprising of 13 Directors including the Chairman, all nominated by the Government, the Secretary, Ministry of Climate Change, in an ex-officio capacity. The Managing Director is the operational head of the firm. The authorized capital of the company is Rs. 2.50 million, divided into 250,000 share of Rs. 10 each. The paid-up capital of the company, which is wholly owned by the Federal Government is Rs. 1.10 million.

PEPAC provides services as Consultant / Advisor in forty two fields which mainly includes; Architectural Planning, Feasibility Studies, Housing / Environmental Planning, Structural & Services Engineering, Regional/ Urban Planning, Quality / Quantity Surveying, Arch. Designing/Interior & Landscaping, Conservation of National Heritage, Construction Management & Contract Administration.

PEPAC develops a public sector pool of professional expertise charged with the responsibility to conceive, plan and realize a comprehensive and well-balanced development of the physical environment relating to different categories of regional planning, land use planning and urban and rural planning etc. It carries out Research Activities in the field of environment planning and in all Development of Architectural Designing. It develops adequately trained manpower in all field of Professional Activities i.e. Development Planning, Regional Planning Development Economics, Landscaping and Landscape Architecture, Environmental Planning, Engineering and Industrial Design, Ecological

5. PAKISTAN PLANNING AND MANAGEMENT INSTITUTE

PPMI's Overview

Pakistan Planning & Management Institute (PPMI) was established to increase awareness and enhance expertise on development process i.e. project identification, formulation, appraisal, implementation, monitoring and evaluation and to assess the requirement of training in management techniques and to improve the quality of project managers through courses on general management, financial management and project management. To meet the emerging needs of the public sector, PPMI is imparting newly recruited officers of Planning Commission and in-service training for planners and project managers in the area of macro-economic, social planning and development process. It undertakes training need assessment of federal agencies in project management, develop course materials, guidelines and manuals. PPMI is housed in its own building including hostel building for participants of training courses.

Major Activities

PPMI organized forty-one training courses out of which twenty-four were regular and seventeen customized training courses during 2020-21. 

Figure-1: Number of Participants in Training Courses








Figure-2: Number of Regular and Customised Training Courses

7. PUBLIC PRIVATE PARTNERSHIP AUTHORITY

Authority's Overview

Government of Pakistan, in order aggressivelv to pursue its development devised goals, has an alternative financing for funding regime infrastructure projects through private sector investment with Planning Commission in-charge of driving the initiative. Under the PSDP+ initiative. numerous federal and provincial implementing agencies, operating in diversified socio-economic sectors, have come with projects which the in private sector can potentially participate in construction/ development and/ or operation/ management/ use of infrastructure goods and services.

Box-1: PSDP+ Portfolio


There are total of more than 180 projects proposed to be undertaken by 21 federal implementing agencies; provinces of Sindh, Punjab, Khyber Pakhtunkhwa & Balochistan; and Gilgit-Baltistan & AJ&K.

Box-2: P3A Projects

'Qualified' Project under the P3A (Amendment) Act 2021 is a PPP project which expects to involve:

- Viability Gap Funding (VGF) from any facility established by the Government for the purpose.
- Sovereign Guarantees issued by the Government as may be prescribed.
- Project Development Funding (PDF) (to meet transaction advisory costs related to the project development) or;
- Any other project as prescribed by the Public Private Partnership Working Party (P3WP).

Such projects range from simple extension/ grant of the licenses and policy interventions required by the Government to more complex Public Private Partnership (PPP) structures involving provision of Viability Gap Funding coupled with Government Guarantees to make the projects financially viable and bankable for the private sector. Details are given in **Box-1 & 2**.



Government of Pakistan, in order to further simplify PPP projects' development and procurement process introduced P3A (Amendment) Act 2021. The said Act empowers implementing agencies to undertake PPP projects on their own which are not 'Qualified' under the said Act and provide project support generate to adequate interest in the Project. In addition to that, the said Act paves the way for promoting private sector centric development by allowing private sector to submit development proposals on unsolicited

Box-3: Sialkot (Sambrial)-Khairan Motorway Project

175

- It is a green-field 69 km toll road proposed to be built on Build-Operate-Transfer – user charge basis at a cost of RS. 27.33 billion.
- The concession period of the Project spreads over 25 years including 2 years construction period and 6 months financial close period. Government of Pakistan is actively supporting the financial viability and bankability of the Project through provision of capital and operational VGF.

Performance Review

The Board of P3A approved the following big-ticket transactions, involving innovative financial structure, during 2020-21:

- Construction of Sialkot (Sambrial)-Kharian Motorway on PPP basis at a cost of Rs. 27.3 billion (details in **Box-3**).
- Construction of Sukkur-Hyderabad Motorway on PPP basis, at a cost of Rs. 200 billion.

P3A is actively supporting in pushing forward PSDP+ portfolio and is indispensable part of the private sector participation drive. During 2021-22, P3A expects to approve the following prominent transactions, including:



- Construction of Sukkur-Hyderabad Motorway on PPP basis.
- Construction of Kharian-Rawalpindi Motorway on PPP basis, at a cost of Rs. 77 billion.
- Karachi Circular Railway, at a tentative cost of Rs. 241 billion.
- Karachi-Pipri dedicated Freight Corridor, at a tentative cost of Rs. 71 billion.

P3A's support to the Government of Gilgit-Baltistan and Government of Balochistan is pivotal in terms of assisting such governments in developing their projects on PPP basis. Besides, P3A has committed to provide funds to various implementing agencies to meet transaction advisory costs related to project development and procurement.

8. CHINA PAKISTAN ECONOMIC CORRIDOR

CPEC's Overview

The China-Pakistan Economic Corridor (CPEC) is a long-term project of the two all-weather friendly neighbours China and Pakistan. The overall

goal of CPEC is to serve as a "Gateway of Prosperity" for both the countries, and the region as a whole. The CPEC Secretariat in the Mo PD&SI in collaboration with stakeholders' relevant implement projects in the designated thematic areas as outlined in the CPEC Long Term Plan (2017-30). Box-1 provides an over view of the Long-Term Plan. Furthermore, CPEC Authority Act 2021 has been promulgated. The aim of the Authority is to perform secretariat tasks and to serve as one-stop shop for all the CPEC related activities.

Box-1: Long Term Plan (LTP) Overview

- Long Term plan for China-Pakistan Economic Corridor (2017-30) was jointly formulated by Pakistan and China.

- The LTP is a living document that is reviewed every two years by the Planning JWG.

The Authority shall be responsible for Planning, facilitating, coordinating, enforcing, monitoring, and evaluating the smooth implementation of all activities related to the CPEC, in accordance with the MoU between the National Development and Reform Commission of the People's Republic of China and the Ministry of Planning Development and Special Initiatives of Islamic Republic of Pakistan on Outline of the Long Term Plan of CPEC signed in Beijing on the 8th of November 2014, as well as decisions taken, from time to time, at meetings of the Joint Cooperation Committee.


Major activities in CPEC during 2020-21 include but not limited to the following:

Additional staff will be assigned to each member and Executive Director.
